ELIMINATION OF RACISM AND RACIAL DISCRIMINATION

Financial situation of the Committee on the Elimination of Racial Discrimination

Report of the Secretary-General

- 1. Pursuant to article 8, paragraph 6, of the International Convention on the Elimination of All Forms of Racial Discrimination (General Assembly resolution 2106 A (XX), annex), States parties shall be responsible for the expenses of the members of the Committee while they are in performance of Committee duties.
- 2. At its forty-seventh session, the General Assembly adopted resolution 47/111 of 16 December 1992, in which it endorsed the amendment to article 8 of the Convention that had been adopted at the Fourteenth Meeting of the States Parties to the Convention in January 1992 (see annex I) and requested the Secretary-General to take the appropriate measures to provide for the financing of the Committee on the Elimination of Racial Discrimination from the regular budget of the United Nations beginning with the budget for the biennium 1994-1995 and to take the necessary measures to ensure that the Committee meets as scheduled until the amendment enters into force.
- 3. Acting in his capacity as depositary, the Secretary-General communicated the amendment to all States parties on 1 March 1993. It will be recalled that at their Fourteenth Meeting, the States parties decided that the amendment would enter into force when accepted by a two-thirds majority of States parties which had so notified the Secretary-General as depositary. As at 30 August 1996, notifications of acceptance had been received from 17 States parties to the Convention.
- 4. At its fiftieth session, the General Assembly adopted resolution 50/137 of 21 December 1995, in which it urged States parties to accelerate their domestic ratification procedures with regard to the amendment to the Convention regarding the financing of the Committee and expeditiously to notify the Secretary-General

in writing of their agreement to the amendment, as decided upon at the Fourteenth Meeting of States Parties on 15 January 1991 and endorsed by the Assembly in its resolution 47/111 of 16 December 1992; requested the Secretary-General to continue to ensure adequate financial arrangements and appropriate means to enable the functioning of the Committee; and requested him to invite those States parties which are in arrears to pay the amounts in arrears and to report thereon to the Assembly at its fifty-first session.

5. In 1996, the Committee held two regular sessions, as had been scheduled. In accordance with resolution 47/111, financing for those sessions was provided from the regular budget. Consequently, no State party assessments were made in 1996. However, a number of States parties are still in arrears from the non-payment of previous assessments. As at 30 September 1996, the total outstanding arrears amounted to \$225,506.24, as detailed in annex II.

ANNEX I

International Convention on the Elimination of All Forms of Racial Discrimination opened for signature in New York on 7 March 1996

Approval by the General Assembly of the proposed amendment to article 8

- 1. The Secretary-General of the United Nations, acting in his capacity as depositary, and with reference to depositary notification C.N.285.1991.TREATIES-4 of 20 December 1991, communicates the following.
- 2. It will be recalled that the States parties to the above-mentioned Convention, at the twenty-second meeting of the Fourteenth Meeting of the States Parties, held on 15 January 1992, decided as follows:
 - "1. To replace paragraph 6 of article 8 of the Convention with the paragraph 'The Secretary-General of the United Nations shall provide the necessary staff and facilities for the effective performance of the functions of the Committee under the Convention.';
 - "2. To add a new paragraph, as article 8, paragraph 7, as follows: 'The members of the Committee established under the present Convention shall, with the approval of the General Assembly, receive emoluments from United Nations resources on such terms and conditions as the General Assembly may decide.';
 - "4. That the amendment shall enter into force when it has been approved by the General Assembly and accepted by a two-thirds majority of States parties which shall have so notified the Secretary-General as depositary;".
- 3. The General Assembly endorsed the amendment of its forty-seventh session (resolution 47/111 of 16 December 1992). In accordance with the above-quoted paragraph 4, it will enter into force when it is accepted by the required number of States parties which shall have so notified the Secretary-General.
