Melinda Kimble was named United States Deputy Assistant Secretary for International Organization Affairs (IO) in June 1991. IO develops and implements United States policy in the United Nations and its specialized agencies and other international organizations.

As United States Deputy Assistant Secretary, Ms. Kimble oversees the entire range of economic and social policy issues that come before the Economic and Social Council and the Second and Third Committees of the General Assembly. She also has direct responsibility for substantive policy development for the key specialized and technical United Nations agencies as well as the voluntary funds and programmes, including the United Nations Development Programme (UNDP), the United Nations Children's Fund (UNICEF) and the World Food Programme. She oversees the work of the Office of Economic and Social Affairs, the Office of Technical Specialized Agencies and the Office of International Development Assistance. In this capacity, she developed the United States negotiating strategies for recent United Nations conferences, including those held at Cairo, Copenhagen and Beijing.

Ms. Kimble is a career Foreign Service Officer, joining the United States Department of State in January 1971. She was promoted to the Senior Foreign Service in 1989 and promoted to the rank of Minister Counsellor in 1993. Before assuming her current position, Kimble was the Director of the Office of Egyptian Affairs in the Near East and South Asia Bureau. From 1987 to 1989, she served as the Deputy and Acting Director of the Office of Monetary Affairs in the Economic and Business Bureau. She has also served in Tunisia, Egypt and Côte d'Ivoire, as well as in the Africa Bureau in Washington.

Ms. Kimble has bachelor's and master's degrees in economics from the University of Denver and a master's degree from Harvard.
