APPOINTMENTS TO FILL VACANCIES IN SUBSIDIARY ORGANS AND OTHER APPOINTMENTS

Confirmation of the appointment of members of the Investments Committee

Note by the Secretary-General

1. As indicated in document A/51/104 of 12 March 1996, it will be necessary for the General Assembly, during its current session, to confirm the appointment by the Secretary-General of three persons to fill vacancies in the Investments Committee resulting from the expiration, on 31 December 1996, of the terms of office of Ms. Francine Bovich (United States of America), Mr. Jean Guyot (France) and Mr. Takeshi Ohta (Japan).

2. In accordance with the provisions of article 20 of the Regulations of the United Nations Joint Staff Pension Fund, the Secretary-General, after consultation with the United Nations Joint Staff Pension Board and the Advisory Committee on Administrative and Budgetary Questions, submits for confirmation by the General Assembly the appointment of Mr. Peter Stormonth Darling (United Kingdom of Great Britain and Northern Ireland) and Mr. Fernando G. Chico Pardo (Mexico), and the reappointment of Ms. Francine Bovich (United States of America) and Mr. Takeshi Ohta (Japan) as members of the Investments Committee for three-year terms of office beginning on 1 January 1997. Mr. Guyot has indicated his wish not to be considered for reappointment. In view of his valuable contribution to the Committee, the Secretary-General proposes, with the endorsement of the Pension Board, to appoint Mr. Guyot as member emeritus effective 1 January 1997.

3. Ms. Bovich has served on the Committee since 1991 and Mr. Ohta since 1995. Mr. Stormonth Darling and Mr. Chico Pardo have been serving as ad hoc members since 1990 and 1996 respectively. The Secretary-General greatly appreciates their willingness to carry on this important international public service.

4. The curricula vitae of the appointees for confirmation are set out in the annex to the present document.

5. In accordance with past practice, the Secretary-General has appointed as ad hoc member Mr. Alexander P. Papamarkou (Greece and United States of America) to serve with the Committee in 1997.
