The General Assembly,

<u>Aware</u> that the development of friendly relations among nations, based on respect for the principle of equal rights and self-determination of peoples, is among the purposes and principles of the United Nations, as defined in its Charter,

<u>Recalling</u> the International Covenants on Human Rights,  $\underline{1}/$  the Universal Declaration of Human Rights,  $\underline{2}/$  the Declaration on the Granting of Independence

to Colonial Countries and Peoples  $\underline{3}$ / and the Vienna Declaration and Programme of Action, adopted at the World Conference on Human Rights on 25 June 1993,  $\underline{4}$ /

<u>Recalling also</u> the Declaration on the Occasion of the Fiftieth Anniversary of the United Nations,  $\underline{5}/$ 

<u>Noting</u> the developments in the Middle East peace process, including the mutual recognition and the signing of the Declaration of Principles on Interim Self-Government Arrangements in Washington on 13 September 1993 by the Palestine Liberation Organization, the representative of the Palestinian people, and the Government of Israel,  $\underline{6}$ / as well as the ensuing implementation agreements, in particular the interim agreement of 28 September 1995,

<u>Affirming</u> the right of all States in the region to live in peace within secure and internationally recognized borders,

1. <u>Reaffirms</u> the right of the Palestinian people to self-determination;

2. <u>Expresses the hope</u> that the Palestinian people will soon be exercising their right to self-determination in the current peace process;

3. <u>Urges</u> all States, specialized agencies and organizations of the United Nations system to continue to support and assist the Palestinian people in their quest for self-determination.
