REPORT BY THE SECRETARY-GENERAL CONCERNING THE CREDENTIALS OF THE REPRESENTATIVES AND DEPUTY AND ALTERNATE REPRESENTATIVES OF THE MEMBERS OF THE SECURITY COUNCIL ELECTED FOR THE PERIOD 1979-1980

- 1. At its 50th and 51st plenary meetings, on 10 November 1978, the General Assembly elected Bangladesh, Jamaica, Norway, Portugal and Zambia non-permanent members of the Security Council for a term of two years, beginning on 1 January 1979.
- 2. Pursuant to rule 15 of the provisional rules of procedure of the Security Council, the Secretary-General wishes to report that, with regard to the representation of the members of the Security Council elected for the period 1979-1980, he has received the communications referred to hereunder.
- 3. <u>Bangladesh</u>. The Secretary-General has received credentials signed on 5 December 1978 by the Minister for Foreign Affairs of Bangladesh appointing Mr. K. M. Kaiser representative of Bangladesh on the Security Council, Mr. Reaz Rahman deputy representative and Mr. Mostafa Faruque Mohammed alternate representative. In the opinion of the Secretary-General, these credentials are in order.
- 4. <u>Jamaica</u>. The Secretary-General has received a telegram dated 22 December 1978 from the Deputy Prime Minister and Minister for Foreign Affairs of Jamaica stating that Mr. Donald Mills has been appointed representative of Jamaica on the Security Council, and Mr. Peter Bartlett and Mr. Stafford Neil alternate representatives. In the opinion of the Secretary-General, this communication constitutes adequate provisional credentials.
- 5. Norway. The Secretary-General has received credentials signed on 22 December 1978 by His Majesty King Olav of Norway appointing Mr. Ole Algard representative of Norway on the Security Council. In the opinion of the Secretary-General, these credentials are in order. The Secretary-General has also received a note verbale from the Permanent Representative of Norway stating that Mr. Tom Eric Vraalsen has been appointed deputy representative of Norway on the Security Council and Mr. Ole Peter Kolby and Mr. Per Aasen alternate representatives. In the opinion of the Secretary-General, this communication constitutes adequate provisional credentials.

- 6. Portugal. The Secretary-General has received a telegram dated 14 December 1978 from the Minister for Foreign Affairs of Portugal stating that Mr. Vasco Futscher Pereira has been appointed representative of Portugal on the Security Council, Mr. Leonardo Mathias deputy representative and Mr. Fernando Andresen Guimaraes, Mr. Filipe de Albuquerque, Mr. Fernando Neves and Mr. João Afonso Ascensão alternate representatives. In the opinion of the Secretary-General, this communication constitutes adequate provisional credentials.
- 7. Zambia. The Secretary-General has received credentials signed on 14 December 1978 by the Minister for Foreign Affairs of Zambia appointing Miss G. C. Konie representative of Zambia on the Security Council, Mr. K. S. Mutukwa deputy representative and Mr. N. J. Sikaulu, Mr. Z. I. Chabala, Mrs. G. N. Mutukwa and Mr. B. M. Sianga alternative representatives. In the opinion of the Secretary-General, these credentials are in order.
