Note by the Secretary-General

1. By a communication dated 18 January 1978, the Secretary-General, in accordance with Article 5 of the Statute of the International Court of Justice, invited national groups to undertake the nomination of candidates for the election, to be held during the thirty-third regular session of the General Assembly, to fill the five vacancies in the International Court of Justice which will occur on 5 February 1979 when the terms of office of the following five members of the Court expire:

Mr. E. Jiménez de Aréchaga (Uruguay);
Mr. H. C. Dillard (United States of America);
Mr. L. Ignacio-Pinto (Benin);
Mr. F. de Castro (Spain);
Mr. P. D. Morozov (Union of Soviet Socialist Republics).

In his communication the Secretary-General drew attention, <u>inter alia</u>, to the provision of Article 5, paragraph 1, of the Statute of the Court that nominations should be undertaken "within a given time", and he requested that nominations should be sent so as to reach him not later than 15 August 1978. Subsequently this deadline was extended to 15 September 1978.

2. In accordance with Article 7 of the Statute of the Court, the Secretary-General has the honour to submit to the General Assembly and to the Security Council an alphabetical list of the candidates for the election of five members of the Court nominated by national groups by 15 September 1978 (see annex).
