SUMMARY STATEMENT BY THE SECRETARY-GENERAL ON MATTERS OF WHICH THE SECURITY COUNCIL IS SEIZED AND ON THE STAGE REACHED IN THEIR CONSIDERATION

Addendum

Pursuant to rule 11 of the provisional rules of procedure of the Security Council, the Secretary-General is submitting the following summary statement.

The list of items of which the Security Council is seized is contained in documents S/12520 of 9 January 1978 and S/12520/Add.17 of 11 May 1978.

During the week ending 16 December 1978, the Security Council took action on the following item:

<u>The situation in Cyprus</u> (see S/11185/Add.28, S/11185/Add.29, S/11185/Add.32, S/11185/Add.34, S/11185/Add.49, S/11593/Add.7, S/11593/Add.8, S/11593/Add.9, S/11593/Add.10, S/11593/Add.23, S/11593/Add.24, S/11593/Add.24, S/11593/Add.49, S/11935/Add.23, S/11935/Add.24, S/11269/Add.50, S/12269/Add.24, S/12269/Add.35, S/12269/Add.36, S/12269/Add.37, S/12269/Add.50, S/12520/Add.23, S/12520/Add.45 and S/12520/Add.47)

At its 2107th meeting, held on 14 December 1978, the Security Council resumed its consideration of the question on the basis of the report of the Secretary-General on the United Nations operation in Cyprus for the period 1 June 1977 to 30 November 1978 (S/12946 and Add.1). The President, with the consent of the Council, invited the representatives of Cyprus, Turkey and Greece, at their request, to participate in the discussion without the right to vote. In accordance with the request from Turkey, the President, with the consent of the Council, extended an invitation under rule 39 of the provisional rules of procedure to Mr. Nail Atalay.

The President called attention to a draft resolution (S/12968) which had been prepared in the course of consultations among the members of the Council. The Council then proceeded to vote on the draft resolution and adopted it as resolution 443 (1978) by a vote of 14 votes in favour, none against, with no abstentions. One member (China) did not participate in the voting.

Resolution 443 (1978) reads as follows:

The Security Council,

Noting the report by the Secretary-General on the United Nations operation in Cyprus of 1 December 1978 (S/12946),

<u>Noting also</u> the concurrence of the parties concerned in the recommendation by the Secretary-General that the Security Council extend the stationing of the United Nations Peace-keeping Force in Cyprus for a further period of six months,

Noting further that the Government of Cyprus has agreed that in view of the prevailing conditions in the island it is necessary to keep the Force in Cyprus beyond 15 December 1978,

<u>Reaffirming</u> the provisions of resolution 186 (1964) of 4 March 1964 and other relevant resolutions,

1. <u>Extends once more</u> the stationing in Cyprus of the United Nations Peace-keeping Force established under resolution 186 (1964) for a further period ending 15 June 1979:

2. <u>Requests</u> the Secretary-General to continue his mission of good offices, to keep the Security Council informed of the progress made, and to submit a report on the implementation of this resolution by 31 May 1979.
