SUMMARY STATEMENT BY THE SECRETARY-GENERAL ON MATTERS OF WHICH THE SECURITY COUNCIL IS SEIZED AND ON THE STAGE REACHED IN THEIR CONSIDERATION

Addendum

Pursuant to rule 11 of the provisional rules of procedure of the Security Council, the Secretary-General is submitting the following summary statement.

The complete list of items of which the Security Council is seized is contained in document S/11935 of 5 January 1976 and the pertinent addenda. During the week ending 10 April 1976, the Security Council took action on the following item:

51. Question concerning the situation in Southern Rhodesia (see S/7382, S/7628, S/7644, S/8502, S/8555, S/8564, S/8612, S/9258, S/9276, S/9293, S/9687, S/9714, S/9721, S/9981, S/9996, S/10402, S/10435, S/10462, S/10492, S/10542, S/10554, S/10557, S/10751, S/10770/Add.6, S/10855/Add.20 and S/10855/Add.21)

The Security Council resumed its consideration of the item at its 1907th meeting, held on 6 April 1976, on the basis of the special report of the Security Council Committee established in pursuance of resolution 253 (1968) concerning the question of Southern Rhodesia on the expansion of sanctions against Southern Rhodesia (S/11913).

The President drew attention to a draft resolution (S/12037) sponsored by Benin, China, France, Guyana, Italy, Japan, the Libyan Arab Republic, Pakistan, Panama, Romania, Sweden, the USSR, the United Kingdom, the United Republic of Tanzania and the United States, which had been elaborated in the course of consultations among all the members of the Council.

The 15-Power draft resolution (S/12037) was adopted unanimously by the Council as resolution 388 (1976). In its operative part it reads as follows:

"1. <u>Decides</u> that all Member States shall take appropriate measures to ensure that their nationals and persons in their territories do not insure: S/11935/Add.14 English Page 2

> (a) Any commodities or products exported from Southern Rhodesia after the date of this resolution in contravention of Security Council resolution 253 (1968) which they know or have reasonable cause to believe to have been so exported;

(b) Any commodities or products which they know or have reasonable cause to believe are destined or intended for importation into Southern Rhodesia after the date of this resolution in contravention of resolution 253 (1968);

(c) Commodities, products or other property in Southern Rhodesia of any commercial, industrial or public utility undertaking in Southern Rhodesia, in contravention of resolution 253 (1968);

2. <u>Decides</u> that all Member States shall take appropriate measures to prevent their nationals and persons in their Territories from granting to any commercial, industrial or public utility undertaking in Southern Rhodesia the right to use any trade name or from entering into any franchising agreement involving the use of any trade name, trade mark or registered design in connexion with the sale or distribution of any products, commodities or services of such an undertaking;

3. <u>Urges</u>, having regard to the principle stated in Article 2 of the United Nations Charter, States not Members of the United Nations to act in accordance with the provisions of the present resolution."
