SUMMARY STATEMENT BY THE SECRETARY-GENERAL ON MATTERS OF WHICH THE SECURITY COUNCIL IS SEIZED AND ON THE STAGE REACHED IN THEIR CONSIDERATION

Addendum

Pursuant to rule 11 of the provisional rules of procedure of the Security Council, the Secretary-General is submitting the following summary statement.

The complete list of items of which the Security Council is seized is contained in document S/11935 of 5 January 1976 and the pertinent addenda. During the week ending 29 May 1976, the Security Council took action on the following items:

The situation in the occupied Arab territories (see S/11935/Add.18, S/11935/Add.19 and S/11935/Add.20)

The Security Council continued its consideration of the question at its 1922nd meeting, held on 26 May 1976. The President stated that after consulting all the members of the Council, he had concluded that a majority of the members were agreed on the text of a statement, which he accordingly read out at the meeting.

The Security Council resumed its consideration of the item at its 1923rd meeting, held on 28 May 1976, and included in its agenda the report of the Secretary-General on the United Nations Disengagement Observer Force covering the period 25 November 1975 to 24 May 1976 (S/12083 and Add.1).

The President called attention to the draft resolution before the Council, S/12088, sponsored by Benin, Guyana, Pakistan, Panama, Romania and the United Republic of Tanzania. The Security Council adopted the draft resolution (S/12088) as resolution 390 (1976) by 13 votes to none. China and the Libyan Arab Republic did not participate in the vote. In its operative paragraph, resolution 390 (1976) reads as follows:

<u>Decides</u>:

- (a) To call upon the parties concerned to implement immediately Security Council resolution 338 (1973);
- (b) To renew the mandate of the United Nations Disengagement Observer Force for another period of six months;
- (c) To request the Secretary-General to submit at the end of this period a report on the developments in the situation and the measures taken to implement Security Council resolution 338 (1973).
