SUMMARY STATEMENT BY THE SECRETARY-GENERAL ON MATTERS OF
WHICH THE SECURITY COUNCIL IS SEIZED AND ON THE STAGE
REACHED IN THEIR CONSIDERATION

Addendum

Pursuant to rule 11 of the provisional rules of procedure of the Security Council, the Secretary-General is submitting the following summary statement.

The complete list of items of which the Security Council is seized is contained in document S/11935 of 5 January 1976 and the pertinent addenda. During the week ending 10 July 1976, the Security Council took action on the following item:

Complaint by the Prime Minister of Mauritius, current Chairman of the Organization of African Unity, of the "act of aggression" by Israel against the Republic of Uganda

By a letter dated 6 July 1976 addressed to the President of the Security Council (S/12126), the Assistant Executive Secretary of the Organization of African Unity (OAU) to the United Nations transmitted a telegram from the Prime Minister of Mauritius, current Chairman of OAU, addressed to the President of the Security Council, concerning the "act of aggression" by Israel against the Republic of Uganda, on 4 July 1976, in which the Prime Minister of Mauritius stated that the heads of State and Government of OAU, requested that the Security Council be immediately convened to consider that matter.

In a letter dated 6 July 1976 addressed to the President of the Security Council (S/12128), the representative of Mauritania requested, on behalf of the Group of African States at the United Nations that, with reference to the above-mentioned telegram from the current Chairman of OAU, the Security Council be convened as a matter of urgency to consider the contents of that communication.

By a letter dated 4 July 1976 addressed to the Secretary-General (S/12123), the representative of Israel transmitted excerpts from the statement of his Prime Minister in the Knesset on that day with regard to the operation conducted by the Israel Defence Forces to rescue the hostages hijacked by the Palestinian terrorists on 27 June 1976 and held in captivity in Uganda. He also requested that the letter and its attachment be included in the agenda of the Security Council.

By a letter dated 5 July 1976 addressed to the President of the Security Council (S/12124), the representative of Uganda transmitted the statement of his Prime Minister concerning the serious incident which occurred at Entebbe International Airport on 3 and 4 July 1976.

At its 1939th meeting, held on 9 July 1976, the Security Council considered the question and included in its agenda the requests for a meeting from the Prime Minister of Mauritius and the representative of Mauritania, respectively, as well as the communications from the representatives of Israel and Uganda. The President, with the consent of the Council, invited the representatives of the Federal Republic of Germany, Guinea, Israel, Kenya, Mauritania, Mauritius, Qatar, Uganda and the United Republic of Cameroon, at their request, to participate in the discussion, without the right to vote.
