#### II. ANNOTATIONS TO THE PROVISIONAL AGENDA

#### Item 1. Adoption of the agenda and organization of work

The provisional agenda for the second session was approved by the Ad Hoc Working Group at its first session.

A proposal for the organization of work of the second session is given in section III below.

- Item 2. Enhancement of the understanding of the implications of the new rules deriving from the Uruguay Round agreements and their follow-up, and identification of where and how developing countries and economies in transition concerned could be assisted to:
  - (a) <u>make use of the special clauses of the Final Act providing</u> differential and more favourable treatment; and
  - (b) implement and benefit from the commitments undertaken

The report on this item (TD/B/WG.8/6) analyses the trading opportunities with respect to three "contingency protection" agreements of the Uruguay Round, i.e. on safeguards, on anti-dumping practices and on subsidies and countervailing measures, to see to what extent these agreements and the national implementing legislation of the major trading nations present new trading opportunities for developing countries and countries in transition. The report seeks to identify the particular benefits arising from the application of differential and more favourable treatment and the difficulties developing countries may face in implementing and benefiting from these commitments.

The report on this item (TD/B/WG.8/7) focuses, in the context of the terms of reference of the Ad Hoc Working Group, on the main problems for enhancing the participation of developing countries and economies in transition in the post-Uruguay Round international trading system and the identification of priority areas for technical cooperation, including national policy-making, institutional capacity building and human resource development, and participation in the multilateral and regional frameworks and negotiations processes.

\* To assist the Ad Hoc Working Group in its deliberations on Item 2, in particular to enhance the understanding of the implications of the new "contingency protection" agreements of the Uruguay Round and their follow-up for developing countries and countries in transition concerned, a panel of experts is being convened to share its views with the Ad Hoc Working Group at its informal deliberations immediately after the opening session of Group on Monday morning, 4 December 1995. These experts are mainly private practitioners in contingency protection trade law and the panel will focus its informal deliberations on: (i) the trading opportunities resulting from three "contingency protection" agreements of the Uruguay Round, i.e. safeguards, anti-dumping practices and subsidies and countervailing measures as to what extent these agreements and the relevant national implementing legislation of the major trading nations present new trading opportunities for developing countries and countries in transition concerned and provide the security for those opportunities; (ii) the identification, with some case studies, of the extent to which the Uruguay Round agreements and the new implementing legislation represent an improvement from the previous system; (iii) the identification of the particular benefits arising from the application of differential and more favourable treatment and the difficulties developing countries and countries in transition concerned may face in implementing and benefitting from the commitments undertaken under these agreements; (iv) the identification of areas in which technical assistance should be strengthened, having in mind the respective problems faced by developing countries and countries in transition concerned.
