The two working groups on the harmonization of classification criteria will be convened in accordance with the decisions taken by the Committee at its eighteenth session (see ST/SG/AC.10/21, paras. 144 to 154) i.e. in the context of global harmonization of classification of criteria, cooperation with the International Labour Organization (ILO) and the Inter-Organization Programme on Sound Management of Chemicals (IOMC) and follow-up to the United Nations Conference on Environment and Development (UNCED). Therefore these groups should be composed of experts familiar with transport legislation and other relevant legislations (work safety, environment, consumer protection).

The working groups on the harmonization of classification criteria will meet in the Plenary room with interpretation during the second week, i.e. there will be no plenary session when these working groups on harmonization meet.
