- ١- عملاً بقرارات المجلس الاقتصادي والاجتماعي ذات الصلة، وبخاصة القرار ٢٥/١٩٨٦، يطلب إلى لجنة حقوق الإنسان أن تقوم في دورتها الثانية والخمسين بانتخاب نصف أعضاء اللجنة الفرعية والعدد المقابل من المناوبين، إن وجد، وفقاً للنمط التالي: أربعة أعضاء من الدول الأفريقية؛ وعضوين من الدول الآسيوية؛ وعضوين من دول أوروبا الشرقية؛ وعضوين من دول أمريكا اللاتينية؛ وثلاثة أعضاء من دول أوروبا الغربية ودول أخرى.
- ٢- وأبلغ الأمين العام، في الوثيقة E/CN.4/1996/104 اللجنة بتسميات المرشحين والمناوبين للانتخاب كأعضاء في اللجنة الفرعية التي وردت حتى ٦ كانون الأول/ديسمبر ١٩٩٥. وتتضمن هاتان الوثيقتان أيضاً البيانات التي وردت عن السيرة الذاتية للمرشحين والمناوبين.
- ٣- ومنذ ٦ كانون الأول/ديسمبر ١٩٩٥، وردت تسميات وبيانات سير ذاتية إضافية بالإضافة إلى رسائل أخرى.
- ٤- وفي ١٨ كانون الأول/ديسمبر ١٩٩٥، أبلغت حكومة الغلبين الأمين العام أنها قررت سحب ترشيحاتها.
- ٥- وتتضمن هذه الوثيقة القائمة المستوفاة لتسميات المرشحين لعضوية اللجنة الفرعية حتى ١٠ كانون الثاني/يناير ١٩٩٦. وتتضمن هذه الوثيقة أيضاً بيانات السيرة الذاتية التي لم ترد في الوثيقة E/CN.4/1996/104 و/أو التي وردت منذ ٦ كانون الأول/ديسمبر ١٩٩٥ (انظر المرفق).
