Subject: REIMBURSEMENT FOR TRAVEL BY PRIVATE MOTOR VEHICLE*

The annex to the present administrative instruction shows the revised schedule of rates of reimbursement applicable to different groups of countries and Territories for travel by private motor vehicle, effective 1 November 1996, and supersedes the annex to administrative instruction ST/AI/224/Rev.1/Amend.28.
