SUMMARY STATEMENT BY THE SECRETARY-GENERAL ON MATTERS OF
WHICH THE SECURITY COUNCIL IS SEIZED AND ON THE STAGE
REACHED IN THEIR CONSIDERATION

1. Pursuant to rule 11 of the provisional rules of procedure of the Security Council, the Secretary-General wishes to submit hereunder the list of items of which the Security Council is currently seized, with references in parentheses to the previous summary statements that have been issued covering consideration of each item. 1/

2. It will be recalled that, in the interest of economy, the Secretary-General reproduces only once annually the full, up-to-date list of items of which the Security Council is seized. In fulfilment of his responsibility under rule 11, an addendum to the basic list is issued weekly, making reference to those items on which further action has been taken by the Council during the week covered or indicating that there has been no change during that period.

3. The last full summary statement (S/1995/40) was issued on 16 January 1995. The last weekly addendum (S/1995/40/Add.51) covered developments up to 30 December 1995.

The Security Council resumed its consideration of the item at its 3616th meeting, held on 5 January 1996, in accordance with the understanding reached in its prior consultations, having before it a letter dated 29 December 1995 from the Secretary-General addressed to the President of the Security Council (S/1995/1068).

The President, with the consent of the Council, invited the representative of Burundi, at his request, to participate in the discussion without the right to vote.

The President stated that, following consultations of the Council, he had been authorized to make a statement on behalf of the Council and read out the text of that statement (for the text, see S/PRST/1996/1; to be issued in Official Records of the Security Council, Fifty-first Year, Resolutions and Decisions of the Security Council, 1996).
