# NOTIFICATION

G.S.R. <u>556</u> (E) In exercise of the powers conferred by Section 9, read with Sect<sup>t</sup>ion 76, of the Narcotics Drugs & Psychotropic Substances Act, 1985 (61 of 1985)<sup>1</sup>, the Central Government hereby makes the following amendment to the Narcotic\_ Drugs and Psychotropic Substances Rules, 1985<sup>21</sup>, namely :-

- 1. (1) These rules may be called the Narcotic Drugs and Psychotropic Substances (Amendment) Rules, 1995.
  - (2) They shall come into force on the date of their publication in the official Gazette.
- 2. In the Narcotic Drugs and Psychotropic Substances Rules, 1985, -
  - $\sqrt{(i)}$  In rule 55, for the entries relating to sub-rule (i) the following shall be substituted, namely.
    - (1) Subject to rule 53, no marcotic drug, or psychotropic substance specified in the Schedule of the Act shall be imported into India without an import certificate in respect of consignment issued by the issuing authority in Form No. 4 appended to these rules.''

/(ii) In rule 57 rule 60 and rule 61 for the word and figure
''Schedule II'' the words ''Schedule of the Act'' shall be
substituted.

(iii) In rule 58:-

(a) for the entries relating to sub-rule (1), the following shall be substituted, namely :-

"Subject to rule 53 and rule 53 A, no narcotic drug, or psychotropic sunstance specified in the schedule of the Act, shall be exported out of India without an export authorization in respect of the consignment issued by the issuing authority in Form No.5 appended to these rules."

<u>1</u>/ E/NL.1985/33 <u>2</u>/ E/NL.1985/34 (b) sub-rule (3) shall be deleted.

(c) Sub-rule (4) shall be renumbered as sub-rule (3).
 (iv) Schedule II and II appearing after Schedule I in these
 Rules shall be deleted. '' Schedule IV'' shall be re-numbered
 as ''schedule II''.

(v) In rule 53 Å, for the word and figure 'Schedule IV'', the word and figure 'Schedule II'' shall be substituted.
(vi) Form No. 6 appearing after the Schedule of these rules shall be deleted.

(vii) Form No. 7 of these rules shall be renumbered as
 Form No. 6 and any reference in the rules to the
 Form No. 7 shall be read as Form No. 6
