Addendum

As indicated in paragraph 4 of document A/C.5/51/22, addenda to that document will be issued as and when appropriate. The annex to the present addendum contains an enumeration of meetings additional to those presented in the annex to document A/C.5/51/22. As regards the meetings listed in the annex to that document, the in-session open-ended working group of the Commission on the Status of Women (item 2) can now be accommodated as a result of the anticipated release of capacity, which had earlier been reserved for servicing other meetings at a different date. The Special Committee on the Charter of the United Nations and on the Strengthening of the Role of the Organization (item 10) has now been scheduled to meet from 27 January to 7 February 1997 and can be accommodated on those dates. The parallel meetings of the Commission on Crime Prevention and Criminal Justice (item 21), to be held at Vienna from 24 April to 8 May 1997, may now be accommodated on the basis of new information provided by the United Nations Office at Vienna.
