Note by the Secretary-General

- 1. The Convention on the Rights of the Child was adopted by the General Assembly in resolution 44/25 of 20 November 1989, and entered into force on 2 September 1990, on the thirtieth day after the date of the deposit with the Secretary-General of the United Nations of the twentieth instrument of ratification or accession.
- 2. As at 1 November 1996, the Convention had been ratified or acceded to by 187 States. A list of States parties, as well as information on the status of the submission of reports by States parties, is to be found in the annex to the present document.
