COMMITTEE ON THE RIGHTS OF THE CHILD Fourteenth session Geneva, 6-24 January 1997

PROVISIONAL AGENDA AND ANNOTATIONS

Note by the Secretary-General

- 1. The fourteenth session of the Committee on the Rights of the Child will be held at the United Nations Office at Geneva from 6 to 24 January 1997. The first meeting of the session will be convened on Monday, 6 January, at 10.30 a.m.
- 2. In accordance with rule 6 of the provisional rules of procedure, the Secretary-General has prepared, in consultation with the Chairperson of the Committee, the attached provisional agenda for the thirteenth session. Annotations to the provisional agenda are also attached.
- 3. Pursuant to rule 32 of the provisional rules of procedure, the meetings of the Committee shall be held in public unless the Committee decides otherwise.
- 4. The attention of the States parties is drawn, in particular, to the annotations to item 4, containing the list of reports that will be before the Committee at its fourteenth session.
- 5. A pre-sessional working group, established in accordance with rule 63 of the provisional rules of procedure, met at the United Nations Office at Geneva from 14 to 18 October 1996.

<u>Annotations</u>

Item 1. Adoption of the agenda

1. Under rule 8 of the provisional rules of procedure, the first item on the provisional agenda shall be the adoption of the agenda, except for the election of officers when required under rule 16. In accordance with rule 9 of the provisional rules of procedure, the Committee may revise the agenda and may, as appropriate, add, defer or delete items. Only urgent or important items may be added to the agenda.

Item 2. Organizational and other matters

2. Under this item, the Committee may wish to consider its programme of work for the session, as well as any other matter concerning the modalities of discharging its functions under the Convention.

- 8. In accordance with rule 68 of the provisional rules of procedure, representatives of the States parties shall be invited to attend the meetings of the Committee when their reports are examined. Such representatives should be able to answer questions put to them by the Committee and make statements on reports already submitted by their State, and may also submit further information.
- 9. In accordance with rule 68 of the Committee's provisional rules of procedure, the Secretary-General has notified the States parties concerned of the opening date, duration and place of the fourteenth session of the Committee, at which their respective reports will be examined, and has invited them to send representatives to attend the meetings of the Committee at which their reports will be examined.

Item 5. Review of developments relevant to the work of the Committee

- 10. Under this item, the Committee will be provided with information on action taken pursuant to recommendations adopted by the Committee at its previous sessions.
- 11. Additionally, the Committee will be informed about developments relevant to its work that have occurred since the preceding session, including developments relating to other human rights monitoring bodies.

Item 6. <u>Cooperation with other United Nations bodies</u>, specialized agencies and other competent bodies

12. Under this item, the Committee may wish to pursue its discussion of ways and areas in which existing cooperation with various relevant bodies could be further strengthened to enhance the promotion and protection of the rights of the child.

Item 7. <u>Methods of work of the Committee, including guidelines</u> for the preparation of periodic reports

- 13. Under this item, the Committee may wish to pursue its discussion concerning the organization of its future work, as well as the procedure to be followed in the consideration of reports by States parties and their follow-up, including where necessary areas identified for technical assistance, and the urgent procedure.
- 14. Under this item, the Committee will have before it a note by the Secretary-General on areas identified by the Committee for technical assistance and advisory services (CRC/C/40/Rev.5).

Item 8. Future meetings of the Committee

15. Under this item, the Committee will be informed of any developments relating to the schedule of its future meetings.

Item 9. Other matters

16. Under this item, members may wish to discuss such other matters relating to the work of the Committee as may be necessary.
