REPORT OF THE SECRETARY-GENERAL ON THE ACTIVITIES OF THE OFFICE OF INTERNAL OVERSIGHT SERVICES

Report of the Fifth Committee

#### I. INTRODUCTION

- 1. At its 3rd plenary meeting, on 20 September 1996, the General Assembly, on the recommendation of the General Committee, decided to include in the agenda of its fifty-first session the item entitled "Report of the Secretary-General on the activities of the Office of Internal Oversight Services" and to allocate it to the Fifth Committee.
- 2. The Fifth Committee considered the item at its 26th, 27th, 29th to 31st, 34th, 35th and 45th meetings, on 11, 13, 14, 19, 21 and 29 November and 2 and 16 December 1996. Statements and observations made in the course of the Committee's consideration of the item are reflected in the relevant summary records (A/C.5/51/SR.26, 27, 29-31, 34, 35 and 45).
- 3. For its consideration of the item, the Committee had before it the following documents:

#### II. CONSIDERATION OF DRAFT DECISION A/C.5/51/L.19

- 4. At its 45th meeting, on 16 December, the Committee had before it a draft decision entitled "Report of the Secretary-General on the activities of the Office of Internal Oversight Services" (A/C.5/51/L.19), which had been submitted by the Chairman.
- 5. At the same meeting, the Committee adopted draft decision A/C.5/51/L.19 without a vote (see para. 6).

### III. RECOMMENDATION OF THE FIFTH COMMITTEE

6. The Fifth Committee recommends to the General Assembly the adoption of the following draft decision:

# Report of the Secretary-General on the activities of the Office of Internal Oversight Services

The General Assembly:

- (a) Decides to continue consideration of the annual report of the Secretary-General on the activities of the Office of Internal Oversight Services $^1$  during its resumed fifty-first session;
- (b) Reaffirms its decision in paragraph 2 of its resolution 50/239 of 7 June 1996 that the reports of the Office of Internal Oversight Services should be considered under the relevant items of the agenda.
