I. INTRODUCTION

- 1. At its 3rd plenary meeting, on 20 September 1996, the General Assembly decided to include in the agenda of its fifty-first session the item entitled "Programme budget for the biennium 1996-1997" and to allocate it to the Fifth Committee.
- 2. The Fifth Committee considered the item at its 7th to 9th, 11th to 15th, 17th, 20th, 23rd, 25th, 32nd, 33rd, 39th, 40th, and 42nd to 46th meetings, on 15, 16, 18, 22 to 25, 29 and 31 October, 4, 7, 8, 25 and 27 November, 11, 13 and 15 to 17 December 1996.
- 3. The comments and observations made in the course of the discussion of the item are reflected in the relevant summary records (A/C.5/51/SR.7-9, 11-15, 17, 20, 23, 25, 32, 33, 39, 40 and 42-46).
- 4. In accordance with the criteria for use of the contingency fund annexed to General Assembly resolution 42/211 of 21 December 1987, the Fifth Committee, at its 46th meeting, on 17 December, considered a consolidated statement of all programme budget implications and revised estimates that were subject to the criteria for the use of the contingency fund. The consolidated amount fell within the available balance of the contingency fund. The Committee therefore proceeded to approve the required amounts under the relevant sections of the programme budget.
- 5. Section II of the present report contains a summary of the recommendations of the Fifth Committee during the fifty-first session of the General Assembly on the revised estimates submitted by the Secretary-General and on the programme budget implications of resolutions adopted by the Assembly, either on the recommendation of its Main Committees or in respect of items considered in plenary.
- 6. Section III of the report provides a summary of the special subjects considered by the Fifth Committee, which led to the adoption of specific decisions to be recommended to the General Assembly.
- 7. The recommendations of the Fifth Committee are contained in section IV of the present report.

II. PROGRAMME BUDGET FOR THE BIENNIUM 1996-1997

- 8. In its resolutions 50/215 A and B of 23 December 1995, the General Assembly approved budget appropriations for the biennium 1996-1997 in the amount of \$2,608,274,000 and income estimates in the amount of \$471,401,700.
- 9. Recommendations of the Fifth Committee during the current session of the General Assembly on revised estimates submitted by the Secretary-General, as well as on the programme budget implications of resolutions adopted by the Assembly under items considered by other Main Committees or in respect of items considered in plenary, have resulted in net increases in the approved level of

appropriations in the amount of \$4,993,100 and a net reduction in the approved income estimates in the amount of \$23,664,100.

10. The revised estimates of expenditure and income approved by the Fifth Committee and the financial implications of resolutions recommended by other Main Committees and subsequently by the General Assembly are indicated, by expenditure and income section, below:

- 11. At its 46th meeting, on 17 December, the Committee considered the revised estimates of expenditure and income to be recommended for approval by the General Assembly for the biennium 1996-1997, as well as the financing of the appropriations for the year 1997. The Committee took the following action:
- (a) The Committee approved the revised budget appropriations for the biennium 1996-1997 (see para. 23, draft resolution II A);
- (b) The Committee approved the revised income estimates for the biennium 1996-1997 (see para. 23, draft resolution II B);
- (c) The Committee approved the draft resolution on the financing of the appropriations for the year 1996 (see para. 23, draft resolution II C).

III. CONSIDERATION OF SPECIAL SUBJECTS

- 1. Revised estimates resulting from the resolutions and decisions of the Economic and Social Council
- 12. The Committee considered this question at its 32nd and 33rd meetings, on 25 and 27 November. It had before it the report of the Secretary-General (A/C.5/51/20). The report of the Advisory Committee on Administrative and Budgetary Questions was presented orally by its Chairman at the 32nd meeting.
- 13. At its 33rd meeting, on 27 November, the Fifth Committee decided, without a vote, to recommend to the General Assembly that it take note of the estimates of \$501,000 under section 13, Crime control, and of \$595,200 under section 14, International drug control, on the understanding that such additional appropriations as might be necessary would be determined in accordance with the procedures for the use and operation of the contingency fund, taking into account the results of the first performance report on the programme budget for the biennium 1996-1997 (see para. 23, draft resolution I A, sect. I).
 - 2. Request for a subvention to the United Nations Institute for Disarmament Research resulting from the recommendations of the Board of Trustees of the Institute on the work programme of the Institute for 1997
- 14. The Committee considered this question at its 39th and 43rd meetings, on 11 and 13 December. It had before it the report of the Secretary-General (A/C.5/51/33). The report of the Advisory Committee on Administrative and Budgetary Questions was presented orally by its Chairman at the 39th meeting.
- 15. At its 43rd meeting, on 13 December, the Fifth Committee decided, without a vote, to recommend to the General Assembly that it take note of the report of the Secretary-General (A/C.5/51/33) and of the recommendations thereon of the Advisory Committee on Administrative and Budgetary Questions, and approve a subvention of \$213,000 for UNIDIR for 1997 (see para. 23, draft resolution I A, sect. II).

3. International Seabed Authority

- 16. The Committee considered this question at its 33rd and 46th meetings, on 27 November and 17 December. It had before it the report of the Secretary-General (A/C.5/51/38) and the related report of the Advisory Committee on Administrative and Budgetary Questions (A/51/7/Add.6).
- 17. At its 46th meeting, on 17 December, the Vice-Chairman, Mr. Klaus D. Stein, introduced a draft resolution entitled "International Seabed Authority" (A/C.5/51/L.39). At the same meeting, the Committee adopted draft resolution A/C.5/51/L.39 without a vote (see para. 23, draft resolution I A, sect. III).

4. First performance report

- 18. The Committee considered this question at its 42nd, 43rd and 46th meetings, on 12, 13 and 17 December. It had before it the report of the Secretary-General (A/C.5/51/38) and the related report of the Advisory Committee on Administrative and Budgetary Questions (A/51/7/Add.6).
- 19. At its 46th meeting, on 17 December, the Vice-Chairman, Mr. Klaus D. Stein, introduced a draft resolution entitled "First performance report" (A/C.5/51/L.38). At the same meeting, the Committee adopted draft resolution A/C.5/51/L.38 without a vote (see para. 23, draft resolution I A, sect. IV).

5. Contingency fund

- 20. The Committee considered this question at its 46th meeting, on 17 December. It had before it the report of the Secretary-General (A/C.5/51/44).
- 21. At the same meeting, the Fifth Committee decided, without a vote, to recommend to the General Assembly that it appropriate the required amounts, as contained in the report of the Secretary-General, and that it note that a balance of \$15,358,200 would remain in the contingency fund (see para. 23, draft resolution I A, sect. V).

6. Implementation of resolutions 50/214 and 50/215

22. At its 46th meeting, on 17 December, the Fifth Committee considered draft resolution A/C.5/51/L.33, submitted by the Vice-Chairman. At the same meeting, the Committee adopted draft resolution A/C.5/51/L.33 without a vote (see para. 23, draft resolution I B).

- 3. <u>Authorizes</u> the Secretary-General to provide conference services for the meetings of the International Seabed Authority to be held from 17 to 28 March and from 18 to 29 August 1997 from the resources available under section 26E, Conference Services, of the programme budget for the biennium 1996-1997;⁵
- 4. <u>Decides</u> to make a provision of \$2,750,500 for the International Seabed Authority for its administrative expenses in 1997 under section 33, International Seabed Authority, of the programme budget for the biennium 1996-1997;
- 5. Recalling its resolutions 50/214, in which it decided, inter alia, that the vacancy rate would be 6.4 per cent for both Professional and General Service posts, 50/215 and 50/216 of 23 December 1995 and 50/230 of 7 June 1996,

Also recalling the request made to the Secretary-General in paragraph 7 of section II of resolution 50/214 to present, as soon as possible, and no later than 31 March 1996, to the General Assembly, through the Advisory Committee on Administrative and Budgetary Questions, a report containing proposals of possible savings for its consideration and approval,

Reaffirming the role of the current intergovernmental process in reviewing the efficiency and reform of the programmes and activities and the need to avoid duplication,

Recognizing the need to integrate all elements of internal reviews of efficiency in the Secretariat,

Recognizing also the role of the Office of Internal Oversight Services and the Office of Programme Planning, Budget and Accounts in management reforms and in ensuring adequate programme delivery and efficiency,

Regretting that the information requested by the Advisory Committee on Administrative and Budgetary Questions on personnel- and programme-related issues, including, <u>inter alia</u>, whether consultants were hired to carry out work previously performed by staff on posts, was not provided,

Recalling its decision 50/506 of 17 September 1996,

- 1. Reaffirms resolutions 41/213 of 19 December 1986 and 42/211 of 21 December 1987;
- 2. <u>Reaffirms also</u> part VI of resolution 45/248 B of 21 December 1990, which relates to the involvement of different bodies in the budgetary process;
- 3. Reaffirms further the requirement of all Member States to fulfil their financial obligations as set out in the Charter of the United Nations promptly and in full;
- 4. <u>Recognizes</u> the detrimental effect of the withholding of assessed contributions on the administrative and financial functioning of the United Nations;
- 5. <u>Reaffirms</u> that the authority to create, transfer and abolish posts under the regular budget is the prerogative of the General Assembly;
- 6. <u>Recalls</u> the authority of the Secretary-General as chief administrative officer, as provided for under Article 97 of the Charter;
- 7. Endorses the report of the Advisory Committee on Administrative and Budgetary Questions, with the exception of the second sentence of paragraph 28 and subject to the provisions of the present resolution;
- 8. Expresses its concern that the report of the Secretary-General does not contain a clear indication of the extent to which the approved vacancy level of 6.4 per cent has been exceeded in order to reach the savings called for in resolution 50/214;
- 9. <u>Reiterates its decision</u> that savings in the proposed programme budget for the biennium 1996-1997 should not affect the full implementation of mandated programmes and activities;
- 10. <u>Reiterates</u> that any proposal to change mandated programmes and activities is subject to prior approval of the General Assembly, through the Fifth Committee and other relevant bodies;
- 11. <u>Notes</u> the assurances of the Secretary-General that he will not take any decision on the involuntary separation of staff members, including those on the redeployment list, to achieve savings in the context of the implementation of General Assembly resolution 50/214;
- 12. Requests the Secretary-General, in the light of General Assembly decision 50/506, to report during the resumed session of the Fifth Committee on the progress achieved in the placement of the staff on the redeployment list, taking into account their skills and experience;
- 13. <u>Requests</u> that the information requested by the Advisory Committee on Administrative and Budgetary Questions in its report⁸ be presented no later than 1 March 1997;

- 14. Requests the Secretary-General, in connection with paragraphs 25 to 31 of the report of the Advisory Committee, to report, through the Office of Internal Oversight Services, no later than 1 March 1997, on the use of consultants and associated contractual procedures in the United Nations during the calendar year 1996;
- 15. Also requests the Secretary-General to review the effect of vacant posts on programme delivery and to recommend, if appropriate, restoration of the funding of these posts in the context of the budget for the biennium 1998-1999;

- 17. <u>Requests</u> the Secretary-General to integrate and harmonize, where appropriate, efficiency reviews, including those of the intergovernmental machinery, with programme planning and budget reviews;
- 18. Also requests the Secretary-General to report to relevant intergovernmental bodies on the efficiency proposals which have programmatic and programme budget implications that require prior legislative approval;
- 19. Regrets that the programme performance report requested in paragraph 11, section II, of resolution 50/214 to be presented no later than the end of the fiftieth session has not been submitted;
- 20. <u>Requests</u> the Secretary-General to present no later than 1 March 1997 the above-mentioned programme performance report on the impact of approved savings measures on the implementation of mandated programmes and activities, and decides to consider it as a matter of priority during the first part of its resumed session;
- 21. <u>Decides</u> that no changes to the budget methodology or established budgetary procedures, practices and Financial Regulations can be implemented without prior review by and approval by the General Assembly, through the Advisory Committee on Administrative and Budgetary Questions, in accordance with agreed budgetary procedures;

- 1. Budget appropriations totalling 1,299,143,900 dollars and consisting of 1,304,137,000 dollars, being half of the appropriations initially approved for the biennium 1996-1997 in resolution 50/215 A of 23 December 1995, less 4,993,100 dollars, being the reduction approved by the Assembly in resolution A above, shall be financed in accordance with regulations 5.1 and 5.2 of the Financial Regulations as follows:
 - (a) 50,817,943 dollars, consisting of:
 - (i) 43,547,850 dollars, being half of the estimated income other than income from staff assessment approved for the biennium 1996-1997 by the Assembly in its resolution 50/215 B of 23 December 1995;

- (ii) Less 2,854,700 dollars, being the reduction approved by the Assembly in resolution B above;
- (iii) 10,124,793 dollars, being the balance in the surplus account as at 31 December 1995;
- (b) 1,248,325,957 dollars, being the assessment on Member States in accordance with its resolution 49/19 B of 23 December 1994, on the scale of assessments for the years 1996 and 1997.
- 2. There shall be set off against the assessment on Member States, in accordance with the provisions of General Assembly resolution 973 (X) A of 15 December 1955, their respective share in the Tax Equalization Fund in the total amount of 183,140,613 dollars, consisting of:
- (a) 192,153,000 dollars, being half of the estimated staff assessment income approved by the Assembly in its resolution 50/215 B;
- (b) Less 20,809,400 dollars, being the estimated decrease in income from staff assessment approved by the Assembly in resolution B above;
- (c) Plus 11,797,013 dollars, being the increase in income from staff assessment for the biennium 1994-1995 compared with the revised estimates approved by the General Assembly in its resolution 50/205 B of 23 December 1995.
