#### I. INTRODUCTION

- 1. The attention of the Special Committee on the Situation with regard to the Implementation of the Declaration on the Granting of Independence to Colonial Countries and Peoples is drawn to the resolutions and decisions of the General Assembly at its fifty-first session, listed in sections II and III below, which are relevant to the work of the Special Committee in 1997.
  - II. GENERAL RESOLUTIONS ON THE IMPLEMENTATION OF THE DECLARATION ON THE GRANTING OF INDEPENDENCE TO COLONIAL COUNTRIES AND PEOPLES
- 2. The Special Committee was established by the General Assembly pursuant to its resolution 1654 (XVI) of 27 November 1961. The Special Committee was requested to examine the application of the Declaration on the Granting of Independence to Colonial Countries and Peoples, contained in Assembly resolution 1514 (XV) of 14 December 1960, and to make suggestions and recommendations on the progress and extent of the implementation of the Declaration.
- 3. By its resolution 1970 (XVIII) of 16 December 1963, the General Assembly decided to dissolve the Committee on Information from Non-Self-Governing Territories, and requested the Special Committee to study the information transmitted under Article 73  $\underline{e}$  of the Charter of the United Nations.
- 4. At the same session and at each subsequent session, the General Assembly, after considering the report of the Special Committee, has adopted a resolution renewing the mandate of the Special Committee.
- 5. At its thirty-fifth session, the General Assembly, on the basis of a recommendation of the Special Committee, adopted resolution 35/118 of 11 December 1980, the annex to which contains the Plan of Action for the Full Implementation of the Declaration on the Granting of Independence to Colonial Countries and Peoples.
- 6. At its forty-third session, the General Assembly adopted resolution 43/47 of 22 November 1988, by which it declared the period 1990-2000 the International Decade for the Eradication of Colonialism.
- 7. At its forty-sixth session, the General Assembly, in its resolution 46/181 of 19 December 1991, adopted as a Plan of Action for the International Decade for the Eradication of Colonialism the proposals contained in the annex to the report of the Secretary-General dated 13 December 1991 (A/46/634/Rev.1). The Plan, inter alia, contained the following provisions:
  - "22. The Special Committee on the Situation with regard to the Implementation of the Declaration on the Granting of Independence to Colonial Countries and Peoples, with the cooperation of the administering Powers, should:

- "(a) Prepare periodic analyses of the progress and extent of the implementation of the Declaration on the Granting of Independence to Colonial Countries and Peoples in each Territory;
- "(b) Review the impact of the economic and social situation on the constitutional and political advancement of Non-Self-Governing Territories;
- "(c) Organize during the Decade seminars in the Caribbean and Pacific regions alternately, as well as at United Nations Headquarters, to review the progress achieved in the implementation of the plan of action, with the participation of the peoples of the Non-Self-Governing Territories, their elected representatives, the administering Powers, Member States, regional organizations, specialized agencies, non-governmental organizations and experts.
- "23. The Special Committee should continue to seek, as a matter of priority, the full cooperation of administering Powers with regard to the dispatch of United Nations visiting missions to Non-Self-Governing Territories.
- "24. The Special Committee, with the cooperation of the administering Powers, should make every effort to facilitate and encourage the participation of representatives of Non-Self-Governing Territories in regional and international organizations, as well as in the specialized agencies of the United Nations system, the Special Committee itself and other United Nations decolonization bodies."
- 8. At its fifty-first session, after considering the report of the Special Committee,  $^2$  the General Assembly adopted resolution 51/146 of 13 December 1996 in which it, inter alia:
  - "5. <u>Approves</u> the report of the Special Committee on the Situation with regard to the Implementation of the Declaration on the Granting of Independence to Colonial Countries and Peoples covering its work during 1996, including the programme of work envisaged for 1997;<sup>3</sup>

" . . .

- "11. <u>Requests</u> the Special Committee to continue to seek suitable means for the immediate and full implementation of the Declaration and to carry out those actions approved by the General Assembly regarding the International Decade for the Eradication of Colonialism in all Territories that have not yet exercised their right to self-determination, including independence, and in particular:
- " $(\underline{a})$  To formulate specific proposals for the elimination of the remaining manifestations of colonialism and to report thereon to the General Assembly at its fifty-second session;
- " $(\underline{b})$  To continue to examine the implementation by Member States of resolution 1514 (XV) and other relevant resolutions on decolonization;

- " $(\underline{c})$  To continue to pay special attention to the small Territories, in particular through the dispatch of regular visiting missions, and to recommend to the General Assembly the most suitable steps to be taken to enable the populations of those Territories to exercise their right to self-determination and independence;
- " $(\underline{d})$  To take all necessary steps to enlist worldwide support among Governments, as well as national and international organizations, for the achievement of the objectives of the Declaration and the implementation of the relevant resolutions of the United Nations;
- "12. <u>Calls upon</u> the administering Powers to continue to cooperate with the Special Committee in the discharge of its mandate and to receive visiting missions to the Territories to secure first-hand information and to ascertain the wishes and aspirations of their inhabitants;
- "13. Also calls upon the administering Powers that have not participated in the work of the Special Committee to do so at its 1997 session".
- 9. By a letter dated 26 July 1996 addressed to the Acting Chairman of the Special Committee (A/AC.109/2068), the Permanent Representative of Afghanistan to the United Nations informed the Acting Chairman of the decision of the Government of Afghanistan to terminate its membership in the Special Committee as from that date. On 9 August 1996, the Acting Chairman transmitted the above-mentioned letter to the President of the General Assembly for appropriate action.
- 10. As at 1 January 1997, the Special Committee was composed of the following 22 members: Chile, China, Congo, Côte d'Ivoire, Cuba, Ethiopia, Fiji, Grenada, India, Indonesia, Iran (Islamic Republic of), Iraq, Mali, Papua New Guinea, Russian Federation, Sierra Leone, Syrian Arab Republic, Trinidad and Tobago, Tunisia, United Republic of Tanzania, Venezuela and Yugoslavia. The membership in 1996 of the subsidiary bodies of the Special Committee is given in the annex to the present document.
  - III. RESOLUTIONS, CONSENSUSES AND DECISIONS CONCERNING SPECIFIC ITEMS CONSIDERED BY THE SPECIAL COMMITTEE IN 1996
- 11. As mentioned in section II above, the General Assembly adopted resolution 51/146 on the Implementation of the Declaration on the Granting of Independence to Colonial Countries and Peoples. The Assembly also adopted eight other resolutions, one consensus and three decisions relating to specific items considered by the Special Committee in 1996 which are listed below. Members will wish to take them into account in drawing up the Special Committee's programme of work for 1997.
- 12. On the recommendation of its Special Political and Decolonization Committee (Fourth Committee), the General Assembly decided to defer consideration of the matter relating to the Non-Self-Governing Territories of American Samoa, Anguilla, Bermuda, the British Virgin Islands, the Cayman Islands, Guam,

Montserrat, Pitcairn, St. Helena, the Turks and Caicos Islands and the United States Virgin Islands until March 1997.
