Note by the Secretary-General

<u>Addendum</u>

1. The Secretary-General has received notification of the resignations of Mr. Vijay Gokhale (India) and Mr. Yuji Kumamaru (Japan) from the Advisory Committee on Administrative and Budgetary Questions. Accordingly, the General Assembly will be required at its current session to appoint two persons to fill the unexpired portion of the terms of office of Mr. Gokhale and Mr. Kumamaru, that is, until 31 December 1998.

2. The Government of India has nominated Mr. Syed Akbaruddin and the Government of Japan has nominated Mr. Fumiaki Toya to fill these vacancies.

3. The curricula vitae of the candidates appear in the annex to the present note.

4. In order to enable the General Assembly to take the required action, it will be necessary to reopen consideration of agenda item 18 (a).
