Proposed programme of work of the Division for Social
Policy and Development for the biennium 1998-1999

Note by the Secretary-General

1. In accordance with regulation 3.1 and rules 103.2, 103.3 and 103.6 of the United Nations Regulations and Rules Governing Programme Planning, the Programme Aspects of the Budget, the Monitoring of the Implementation and the Methods of Evaluation (ST/SGB/PPBME Rules/1 (1987)), the intergovernmental body concerned with specific programmes is requested to provide comments on the proposed work programme for the next biennium. The annex to the present note contains initial proposals being considered by the Secretary-General for incorporation in the programme budget for the biennium 1998-1999 in the field of social development.

2. The Commission may wish to comment on the proposed programme of work of the Division for Social Policy and Development for the biennium 1998-1999, bearing in mind that it will be reviewed by the Committee for Programme and Coordination, the Advisory Committee on Administrative and Budgetary Questions and the General Assembly before approval by the Assembly at its fifty-second session.

PROPOSED PROGRAMME OF WORK FOR THE BIENNIUM 1998-1999 FOR THE
DIVISION FOR SOCIAL POLICY AND DEVELOPMENT OF THE DEPARTMENT
FOR POLICY COORDINATION AND SUSTAINABLE DEVELOPMENT OF THE
UNITED NATIONS SECRETARIAT

1. The proposed programme of work is an elaboration of the activities in the field of social development to be carried out by the Division for Social Policy and Development of the Department for Policy Coordination and Sustainable Development of the United Nations Secretariat for the biennium 1998-1999. It has been prepared within the framework of programme 5 of the medium-term plan for the period 1998-2001, adopted by the General Assembly in its resolution 51/219. It also follows upon the programme of work of the Commission for Social Development decided on by the Economic and Social Council in its resolution 1996/7, and on the Copenhagen Declaration on Social Development^a and Programme of Action of the World Summit for Social Development,^b adopted by the Summit, held at Copenhagen in March 1995, and endorsed by the Assembly in its resolution 50/161.

2. The proposed programme of work has been designed to undertake follow-up action relating to the World Summit for Social Development; it will seek to strengthen policy dialogue and support for international cooperation for development from the social perspective, with particular attention to the three core Summit issues of poverty eradication, employment generation and social integration. Activities will focus on furthering implementation of the Copenhagen Declaration and Programme of Action, and related international instruments which include the World Programme of Action concerning Disabled Persons,^c the Standard Rules on the Equalization of Opportunities for Persons with Disabilities,^d the World Programme of Action for Youth to the Year 2000 and Beyond,^e the International Plan of Action on Ageing,^f and the United Nations Principles for Older Persons,^g as well as on follow-up to the International Year of the Family (1994).

3. The Division will direct major focus during the biennium 1998-1999 on strengthening and improving substantive services for the annualized sessions of the newly expanded Commission for Social Development. Its work programme has been planned around three issue clusters, reflecting key dimensions of the Copenhagen Declaration and Programme of Action:

- (a) Social policies and planning;
- (b) Social institutions and participation;
- (c) Social integration.

(a) Social policies and planning

With its main focus on follow-up to the World Summit for Social Development, the objective of this activity would be to provide information and analyses of issues and trends from the social perspective and to formulate strategies and policy options to implement the objectives of the Summit. The activity would seek to contribute knowledge and understanding of development from the social perspective, with special emphasis on information and outreach among the multifarious Summit constituencies. Monitoring, coordination and analytical support would be provided to United Nations system-wide efforts in support of the first United Nations Decade for the Eradication of Poverty (1997-2006).

(b) Social institutions and participation

The objective of this activity would be to provide Member States with information and analyses of issues and trends in institutional arrangements and participation of civil society in development. Special attention would be directed to the International Year of the Family (1994) with a view to formulating family-sensitive strategies and policy options and measures to attain them. The activity would also contribute knowledge and understanding of the role of cooperatives in the promotion of people-centred livelihoods and improved well-being in line with the objectives of the Summit. In addition, the activity would review and assess issues and trends in institutional development and their implications for promoting social cohesion under rapid economic and social change.

(c) Social integration

The objective of this activity would be to undertake efficient and effective monitoring, coordination and outreach in support of international instruments in the social field, including the Copenhagen Declaration on Social Development and Programme of Action of the World Summit for Social Development, the World Programme of Action concerning Disabled Persons, and the Standard Rules on the Equalization of Opportunities for Persons with Disabilities, the International Plan of Action on Ageing, and the World Programme of Action for Youth to the Year 2000 and Beyond. Emphasis will be accorded to providing information and analyses on issues in policy options and measures that would further social integration and full and effective participation of civil society, on the basis of equality, in development. Major focus will be directed to substantive preparations for the cross-cutting priority themes of the thirty-sixth and the thirty-seventh sessions of the Commission for Social Development - "social integration and participation" and "social services for all" - respectively, as well as preparations for the observance in 1999 of the International Year of Older Persons.
