ADOPTION OF THE BUDGET FOR 1996 AND 1997 AND THE SCALE OF ASSESSMENT FOR CONTRIBUTIONS OF STATES SIGNATORIES

Decision

The Preparatory Commission,

1. Appropriates an amount of 140,400 United States dollars for the budget expenses of the Preparatory Commission during the period from 20 November to 31 December 1996, as indicated in annex I;
2. Appropriates an amount of 33,200 United States dollars for non-recurrent expenditures incurred by the Secretary-General in accordance with General Assembly resolution 50/245 of 10 September 1996, as indicated in the appendix to annex I;
3. Decides that the amounts in paragraphs 1 and 2 shall be initially financed from contributions by Member States in accordance with the 1996 scale of assessment contained in part I of annex IV;
4. Appropriates an amount of 296,400 United States dollars for the budget expenses of the Preparatory Commission during the period from 1 January 1997 to 11 March 1997, as indicated in annex II;
5. Appropriates, on the basis of an exchange rate of 10.8 Austrian schillings to one United States dollar, an amount of 27,458,327 United States dollars for the budget expenses of the Preparatory Commission during the period from 12 March 1997 to 31 December 1997, as indicated in annex III;
6. Decides that the amounts in paragraphs 4 and 5 shall be initially financed from contributions by Member States in accordance with the 1997 scale of assessment contained in part II of annex IV;
7. Decides that advance payments by Member States for the start-up costs of the Preparatory Commission shall be deducted in an appropriate way from their assessments to the budget(s) of the Preparatory Commission;

8. Requests Member States to pay those assessed amounts in full within 30 days of the receipt of the communication of the Executive Secretary requesting payment;

9. Authorizes the Executive Secretary to incur expenditures not exceeding the amount of 27,458,327 United States dollars and in accordance with appropriations specified in annex III, including the contingency reserve, as well as to reimburse the Secretary-General of the United Nations for those expenses set out in annex I with appendix and annex II, incurred by him in accordance with General Assembly resolution 50/245.
