On 16 November 1986, was appointed Judge on the Lower Criminal Court and similar courts, handling criminal cases that came before him.

On 19 February 1991, was appointed Judge on the Higher Civil Court and similar courts, dealing with cases in both their civil and their criminal aspects.

In 1992, was sent to the United States to obtain a Master's Degree in Law.

On 26 February 1995, was appointed Judge on the Appeals Court, handling both civil and criminal cases coming before it.

On 23 February 1997, was appointed Vice-President of the Appeals Court, an office he continues to hold.

I was appointed to the Special Presidential Commissions of Inquiry Nos. 1 and 2 of 1994 in terms of law No. 7 of 1978 chapter 9 of the legislative enactments of Sri Lanka as amended by Act No. 4 of 1978, as Chairman by Her Excellency the President of Sri Lanka to inquire into and obtain information in respect of:

(a) The circumstances relating to the assassination of Lieutenant-General D. Kobbekaduwa and nine others and causing grievous injury to another at Araly Point, Kayts on 8 August 1992 and the person or persons directly or indirectly responsible for such assassinations.

(b) The circumstances relating to the assassination of late Lalith W. Athulathmudali, Presidents Counsel on 23 April 1993 at Kirulapone and the person or persons directly or indirectly responsible for such assassination.

The Commissioners who were appointed including the Chairman were sitting judges of the Courts of Sri Lanka, the Chairman being a judge of the Supreme Court.

I retired from office as a Supreme Court Judge on reaching the age of retirement. I, however, continue serving as Chairman of both Commissions of Inquiry until their conclusion which is expected shortly.

Judge of the Supreme Court of Sri Lanka

1 March 1988 to 30 August 1996

Elevated to the Supreme Court Bench, the Apex Court in the Republic on 1 March 1988 by late President of Sri Lanka J. R. Jayewardene.

The Supreme Court is the highest superior court of record in the Republic created by the second Republican Constitution of 7 September 1978 and consisting of the Chief Justice and not less than 6 or more than 10 other justices.

The jurisdiction of the Supreme Court is manifold - it has jurisdiction in respect of:

- (a) Constitutional matters
- (b) Protection of Human Rights
- (c) Final Appellate Jurisdiction
- (d) Consultative Jurisdiction
- (e) Election petition appeals
- (f) Breach of privileges of Parliament
- (g) Other matters which Parliament may by law vest or ordain.

#### Member of Judicial Services Commission

Whilst being a member of the Supreme Court I was appointed in 1991 to serve as a member of the Judicial Services Commission by late President Premadasa. This is an independent constitutional body with powers of appointment, transfer, disciplinary control and dismissal of judicial officers of the Original Courts and scheduled public officers like Presidents of Labour Tribunals. The Commission can also make rules regarding schemes of recruitment and procedure for the appointment of judicial officers and make provision for the exercise, performance and discharge of the functions of such Commission.

#### Member of the Judges Institute

At the same time I was appointed to serve as a member of the Judges Institute Board by the late President R. Premadasa. This is a statutory body governing the training of District Judges, Magistrates, Labour Tribunal Presidents and Primary Court Judges in all aspects of judicial hearing and procedures, decision-making, keeping of records and accounts and administration of the court. The directorate consists of retired Superior Court Judges. Seminars and lectures by senior judges and visiting foreign academic and judicial personnel are included. This is done with the approval of the Judicial Services Commission.

#### Acting Chief Justice

Being the Senior Judge of the Supreme Court I served as Acting Chief Justice in the absence of the Chief Justice from the country in April and December 1995. These appointments were by the present President of Sri Lanka Her Excellency Chandrika Kumaratunga.

Served as Acting Chief Justice on two occasions in 1994 and 1993 being so appointed by retired President D. B. Wijetunge.

Served as Acting Chief Justice in September 1991 and was so appointed by the late President R. Premadasa.

Represented Sri Lanka at the Commonwealth Law Conference held in Cyprus in 1993.

President Court of Appeal

February 1988

Prior to being appointed to the Supreme Court Bench, I served as President of the Court of Appeal of Sri Lanka.

Judge of the Court of Appeal

November 1984-January 1988

The Court of Appeal of Sri Lanka is also a superior Court of Record created by the Constitution. It consists of the President and not less than 6 or no more than 11 other judges. I was appointed to this court by the late President J. R. Jayewardene. The jurisdiction of the Court of Appeal consists of the correction of all errors in fact or in law which shall be committed by any Court of First Instance. Tribunal or other Institution and sole and exclusive cognizance by way of appeal, revision and retribute in intergram of all causes, suits, actions, prosecutions, matters and things of which the Court of First Instance may have taken cognizance.

However, the substantial rights of parties should have been affected or a failure of justice occasioned. The powers of appeal are to affirm, reverse, correct or modify any judgement, order, decree or sentence and give directions to the inferior courts. It has also the power to admit new evidence.

The Court of Appeal may also inspect and examine the records of any Court of First Instance, Tribunal etc. and grant and issue orders in the nature of writs of certiorari, prohibition, procedendo, mandamus and quo warranto. The Court may also grant and issue orders in the nature of habeas corpus and the court also has power to issue injunctions to prevent irremediable mischief. It also hears election petitions, may inspect records and in the exercise of revisionary powers, make any order as the interest of justice may require.

Judge of the High Courts of Sri Lanka

November 1976 to October 1984

Served in the following High Courts of Sri Lanka: Kegalle, Kandy, Galle, Avissawella, Kalutara and Colombo.

Prior to serving in the Appellate Courts, I served as a Judge of the High Courts which is the highest court exercising criminal jurisdiction. I was appointed to this post by late President W. Gopallawa under the first Republic Constitution of 1972.

The High Court deals with indictable offences of grave crimes such as offences against the State, murder, rape, voluntarily causing grievous hurt, kidnapping, abduction, fraud etc. and conspiracy to commit or abet such offences. Under the administration of justice law of 1974 (since repealed) it exercised concurrent civil jurisdiction with the District Courts. Today it exercises besides criminal jurisdiction a defined appellate jurisdiction in the provinces.

Notable case-study

One trial which received much media publicity both in Sri Lanka and abroad was the trial of Reverend Matthew Peiris. I was President of the High Court Trial at Bar of three judges requested by counsel on behalf of the accused Reverend Matthew Peiris where he and a woman friend were tried upon charges of conspiracy and murder of two persons to wit: the priest's wife and the woman's husband by the administration of poison to wit: the secret administration of drugs compelling the reduction and fluctuations of blood sugar levels over a period ending in coma and death simulating pancreatic disorder and insulinomas along the intestinal wall. The conviction of Reverend Peiris was upheld by the Appeal Court and the Supreme Court in subsequent appeals. The woman was acquitted for what the Appeal Court felt was insufficiency of evidence of actual involvement.

First Secretary to the Sri Lanka Mission to the United Nations, New York 1974-1976

Served as First Secretary to the Sri Lanka Mission to the United Nations, New York on transfer from the Justice Ministry to the Foreign Ministry. I was responsible for Sri Lanka co-sponsoring the Resolution on Disarmament with Sweden.

Crown Counsel - Attorney General's Department

The early years of my professional legal career were spent in the Department of the Attorney General as a Crown Counsel. I appeared in most criminal courts in the island both as a trial lawyer or Crown Counsel in Appellate proceedings. I obtained considerable experience in the field of trial proceedings in criminal cases, indictment, plea bargaining, prosecution, sentencing etc.

Whilst a Crown Counsel, I was one of a small team of Crown Lawyers assisting the police and services in the processing of information gathered by investigators about those who participated in the armed uprising under the banner of the Peoples Revolutionary Front (JVP) attacking police stations, government institutions and buildings, damaging roads, bridges and communications and actually confronting the services for a short period in April 1971 in certain areas with a view to overthrowing the Government. This exercise with the Defence Ministry took nearly one and one half years before some of the insurgents, mostly the leadership, were brought to trial before five Judges of the Supreme Court. I appeared for the Crown in some cases and was responsible for the outright release of about 16,000 youths in custody without any conditions in the hope of rehabilitation under government programmes. The leaders were indicted in separate cases areawise. I ended my career in the Attorney General's Department as a Senior State Counsel.

Prior to joining the official bar I practised as an Advocate of the Supreme Court.
