<u>Addendum</u>

- 1. This addendum is submitted in response to General Assembly decision 51/466 of 3 April 1997, by which the Secretary-General was requested, <u>inter alia</u>, to update the information presented in his report on gratis personnel provided by Governments and other entities (A/51/688 and Corr.1), including the nationality of gratis personnel, detailed descriptions of the functions entrusted to them and any change on the use of gratis personnel after 31 October 1996.
- 2. The other information requested by the General Assembly in that decision, on the methodology and level to be applied to administrative support costs, including their legislative basis, and a review of the proposed guidelines annexed to the report of the Secretary-General, appears in addenda 1 and 3, respectively.
- 3. As also requested by the General Assembly in its decision 51/466, the number of gratis personnel implementing mandated activities mentioned in paragraphs 24 to 40 of the report of the Secretary-General has not increased since the adoption of the decision.
- 4. For the purposes of deliberations on the question of gratis personnel in the context of budgets reviewed and approved by the General Assembly, this addendum excludes the gratis personnel previously listed for the United Nations Special Commission.
- 5. Between 31 October 1996 and 31 March 1997, there was a net reduction of 30 in the number of gratis personnel. While the number of type I gratis personnel

decreased by 36 (from 238 to 202), the number of type II gratis personnel increased by six (from 328 to 334).

- 6. The number of type I gratis personnel by department/office is presented in annex I, and the number and nationality of type II gratis personnel by department/office are presented in annexes II and III, respectively. Similar information for the Department of Peacekeeping Operations is presented separately in annex IV, and annex V shows the distribution of gratis personnel in that Department.
- 7. Descriptions of the functions assigned to gratis personnel will be made available to the General Assembly during its deliberations.
