Section 17

Economic and social development in Asia and the Pacific

(Programme 15 of the medium-term plan for the period 1998-2001)

Overview

- 17.1 ESCAP is responsible for the implementation of the programme. The activities are carried out at ESCAP headquarters in Bangkok and the ESCAP Pacific Operations Centre located in Vanuatu.
- 17.2 The levels of development among the members and associate members of ESCAP are diverse, with its membership encompassing developed countries, newly industrialized economies, least developed, landlocked and island developing countries, and countries with economies in transition from centrally planned economies to market economies.
- 17.3 In order to meet the challenges of responding to the diverse needs of its members and associate members, the Commission will continue during the biennium 1998-1999 to focus on three major themes, namely:

 (a) the promotion of regional economic cooperation in such essential areas as trade, investment, building of technological capabilities, transport and infrastructure development; (b) environment and sustainable development that seeks to contain environmental degradation and emphasizes sound management of non-renewable resources; and (c) the promotion of the formulation and implementation of effective social policies, action plans and programmes aimed at alleviating poverty, enhancing the quality of life of all social groups and pursuing vigorous development of the region's human resources. The Commission will moreover continue to facilitate the sharing of experiences among countries through technical cooperation among developing countries and South-South cooperation and to maximize its role as a centre for policy research, analysis and information for the benefit of its members.
- 17.4 The ESCAP work programme in the biennium will accelerate at the regional level the follow-up to the declarations and programmes of action adopted by the recent global conferences to support national and subregional efforts. ESCAP will enhance its lead role in organizing meetings of heads of subregional organizations and in attaining a unified and effective United Nations system-wide approach to regional development through the Regional Inter-agency Committee for Asia and the Pacific and its subcommittees. Through the latter mechanisms, ESCAP will continue to reinforce inter-agency collaboration with a view to pooling resources in the United Nations system for the formulation and implementation of technical assistance programmes to benefit countries in the region.
- 17.5 In the biennium, emphasis will be placed in particular on improving the capacities of least developed, landlocked and island developing countries, as well as the countries with economies in transition, to be integrated more closely into the region's dynamic development and in international development in the economic and social fields.
- 17.6 The programme structure of ESCAP has been revised from six subprogrammes in the biennium 1996-1997 to 10 subprogrammes in the biennium 1998-1999, following the structure of the medium-term plan for the period 1998-2001 (A/51/6/Rev.1 and Rev.1/Corr.1). This change will enhance accountability by ensuring that responsibility for the delivery of outputs and for achieving the results intended for the programme is clearly identified.

- 17.7 Other efforts will be made to reduce the frequency of issuance of many recurrent publications. Furthermore, the exchange and dissemination of information will increasingly be effected through electronic means rather than conventional publications in hard copy. Public information materials will be disseminated to create a greater awareness of the priority activities of ESCAP, all of which are geared to benefit its member countries.
- 17.8 The overall level of resources of \$67,911,900 proposed for the biennium 1998-1999 reflects a growth of \$424,600 (or 0.6 per cent). This growth represents the combined effect of the following: (a) the redeployment to this section of 3 posts (1 P-5, 1 P-3 and 1 Local level) and the non-post resources from UNCTAD to ESCAP for the UNCTAD/ESCAP Joint Unit on Transnational Corporations; (b) the delayed impact of the P-5 post established in the biennium 1996-1997; (c) the new standardized vacancy rates; (d) the proposed abolition of 50 posts (18 Professional, 30 Local level and 2 Field Service posts); and (e) increases and decreases under various objects of expenditures reflecting a shift in the use of resources which would enable a leaner ESCAP to carry out its mandated programme of work more efficiently.
- 17.9 The estimated percentage distribution of the total resources of ESCAP in 1998-1999 would be as follows:

17.10 The Commission, which has 51 member and 9 associate member countries and territories, provides overall direction to the work of the secretariat and reports to the Economic and Social Council. It holds regular annual sessions at the ministerial level. The intergovernmental structure subsidiary to the Commission comprises three thematic committees (the Committee on Regional Economic Cooperation, the Committee on Environment and Natural Resources Development and the Committee on Socio-Economic Measures to Alleviate Poverty in Rural and Urban Areas), two other committees (the Committee on Transport, Communications, Tourism and Infrastructure Development, and the Committee on Statistics), and two special bodies (the Special Body on Least Developed and Landlocked Developing Countries and the Special Body on Pacific Island Developing Countries). Subject to the approval of the Commission, ad hoc

ministerial conferences and ad hoc intergovernmental meetings may also be held during the biennium. In addition to the subsidiary bodies of the Commission, an Advisory Committee of Permanent Representatives and other Representatives Designated by the Commission meets each month to advise and assist the Executive Secretary in the exercise of his functions and to carry out liaison between the Commission and the secretariat. Meetings of the Commission, its committees and special bodies are normally held at the United Nations Conference Centre at Bangkok. If held at some other location at the invitation of a member Government, all additional costs are borne by the host country.

Resource requirements (at current rates)

Other staff costs

17.11 An estimated amount of \$373,300, reflecting a reduction of \$60,300, is requested for temporary assistance for meetings, particularly for interpretation and translation required in connection with the annual Commission sessions and meetings of committees, intergovernmental and special bodies, and ad hoc ministerial conferences. The reduction is due to the reduced volume of documentation as mandated by the Commission, streamlined work methods, and improved processing equipment within the ESCAP Languages Services Section.

Consultants and experts

17.12 An estimated amount of \$19,500, reflecting a reduction of \$28,300, is requested to provide expertise in connection with the preparation of special thematic studies.

Travel

17.13 An estimated amount of \$456,600, reflecting an increase of \$85,300, is requested for the travel costs of conference-servicing staff from Geneva to service the Commission sessions and other meetings held under the auspices of ESCAP. The additional amount is due to the increased use of headquarters conference-servicing staff instead of retaining around the year permanent capacity for editing and translation as in the past.

Contractual services

17.14 An estimated amount of \$58,900, reflecting a decrease of \$37,200, is requested to provide for editing services during periods of peak workload, in particular for the Commission's pre-session documentation, all the documentation of the Committee on Regional Economic Cooperation, and the annual publication of the *Economic and Social Survey of Asia and the Pacific* and to provide for printing costs of the special thematic studies mandated by the Commission.

General operating expenses

17.15 Based on actual requirements, an amount of \$11,800 is requested for miscellaneous services associated with the annual Commission sessions.

Hospitality

17.16 Resources for official hospitality extended on behalf of the organization to delegations/participants to the annual Commission sessions is proposed to be maintained at \$5,900.

Supplies and materials

17.17 An estimated amount of \$20,000, reflecting a reduction of \$10,100, is proposed for supplies and materials for holding the Commission sessions and other meetings.

17.18 The Office of the Executive Secretary provides overall direction, supervision and management of the secretariat and substantive and support services to the Commission and its subsidiary bodies. It promotes economic and social development and regional cooperation among the member and associate member countries of the Commission through the implementation of its legislative mandates and the approved programme of work.

Resource requirements (at current rates)

Posts

17.19 The estimated requirements of \$1,515,900, reflecting a negative resource growth of \$38,800, would provide for four Professional and higher level posts and six Local level posts as shown in table 17.6 above. It is proposed to redeploy one Local level post to subprogramme 6, Poverty alleviation: rural and urban development, to strengthen that area.

Consultants and experts

17.20 The amount of \$26,400 previously allocated for consultants is proposed to be discontinued.

Travel

17.21 An estimated requirement of \$167,000, reflecting an increase of \$10,500, is proposed for travel of the Executive Secretary and his immediate staff to attend meetings within and outside the region, for consultations with Governments and intergovernmental and non-governmental organizations, for coordination with other United Nations entities and to represent the Secretary-General, as required.

- 17.23 The work under this subprogramme will be carried out by the International Trade and Economic Cooperation Division under the guidance of the Committee on Regional Economic Cooperation.
- 17.24 The focus of work will be to implement the Action Programme for Regional Economic Cooperation in Trade and Investment. Policy analyses will be carried out with the view to addressing the emerging challenges and opportunities in the region in the light of regional and global developments. Exchange of experiences and best practices will be facilitated through dissemination of research and extension of technical assistance and advisory services. Emphasis will continue to be placed on issues arising from the implementation of the Uruguay Round agreements and their implications for the region. There will also be special focus on the promotion of regional cooperation for enhancing trade efficiency and electronic commerce, as well as promotion of exports of developing countries with particular attention to the areas of commodities, textiles and exports of small and medium-sized enterprises and in this context, special emphasis will be devoted to the needs of the least developed, landlocked and island developing countries and the disadvantaged countries with economies in transition. More specifically, activities will aim at assisting the least developed countries in harmonizing their trade liberalization commitments with their national priorities and realizing the full potential of their exports in areas where they have comparative advantage; the Pacific island developing countries in diversifying their trade and economic links; and the disadvantaged countries with economies in transition, in particular those countries that are members of the Commonwealth of Independent States (CIS), to renew their intra-trade relations and their economic integration into the region. The proposed activities are also aimed at enhancing institutional capacitybuilding and strengthening networks of institutions which support trade and investment flows. In addition, activities will be undertaken to promote private capital flows for trade related investment including through the development of capital markets. Cooperation between countries will be encouraged to promote capital market development in the developing countries of the region, which would include those with economies in transition. Activities will also address the need for strengthening regional information services for trade and investment as well as promotion of intraregional and interregional cooperation aimed at expansion of trade and investment flows.

Activities

- 17.25 During the biennium 1998-1999, the following activities will be undertaken:
 - (a) Servicing of intergovernmental/expert bodies
 - (i) Substantive servicing of meetings. Twelve plenary and 4 committee sessions of the Commission; 6 plenary meetings of the Committee on Regional Economic Cooperation and 12 plenary meetings of its Steering Group; 8 plenary meetings of the Consultative Meeting among the Executive Heads of Subregional Organizations and ESCAP; and 12 plenary meetings of the Standing Committee of the Bangkok Agreement;

Seven regional seminars/workshops/ symposia on challenges arising from the Uruguay Round agreements, including assistance for accession of non-WTO members; six regional seminars on the promotion of exports of developing countries with emphasis on least developed, landlocked and island developing countries, and on countries with economies in transition; one regional seminar on the promotion of commodity trade through the use of market based mechanisms; four regional workshops on the strengthening of trade and investment information infrastructure and management; two regional/national workshops on the enhancement of regional cooperation in trade facilitation and electronic commerce; three regional seminars on promotion of economic cooperation among developing countries/technical cooperation among developing countries and tripartite cooperation in trade and investment; one regional workshop on the development of stock markets; three seminars on strengthening of intra-subregional cooperation and inter-subregional linkages in trade and investment; three regional seminars/workshops on enhancing international competitiveness of export-oriented small and medium-sized enterprises through promotion of sustainable development policies; interregional seminar on promotion of economic cooperation among the littoral states of the Bay of Bengal in the context of wider cooperation in the Indian Ocean Basin; one regional seminar on market access issues in the context of special trading arrangements and WTO; six workshops on enhancing national institutional capacity and regional networks supporting trade and investment flows; and two seminars/symposia on the promotion

of interregional cooperation on issues concerning regional and global trading and investment environment.

Resource requirements (at current rates)

Posts

17.26 Staff costs in the amount of \$3,656,900 relate to 14 Professional and higher level posts and 11 Local level posts as shown in table 17.10 above. These staffing requirements reflect the redeployment to this subprogramme of two Professional (one P-5 and one P-3) and one Local level posts from UNCTAD (section 11A) and the proposed abolition of two Professional posts (one P-4 and one P-3; the P-3 post is proposed to be abolished effective 1 January 1999). These posts are not required for fulfilment of the programme of work as a result of the use of improved methods of work. The resource growth of \$508,600 represents the combined effect of the redeployment and abolition of posts and the application of new standardized vacancy rates.

Consultants and experts

17.27 An estimated provision of \$136,600 is proposed as follows: (a) \$98,700 for specialized consultancy services not available in the secretariat for the preparation of the documentation and electronic issuance on: regional economic cooperation; Bangkok Agreement; promotion of inter-subregional cooperation; institutional issues for trade facilitation and electronic commerce; commodity-related issues; ESCAP Trade Facilitation Information (TraFIX) on the World Wide Web; and the promotion of investment opportunities, in particular through the development of capital markets; and (b) \$37,900 for three expert group meetings on institutional issues for trade facilitation and electronic commerce; regional trade and investment information networking; and commodity-related issues as reflected in paragraph 17.25 (a) (iii) above. The growth of \$112,300 results from the redeployment of the resources for consultants for the UNCTAD/ ESCAP Joint Unit on Transnational Corporations (\$58,700) and the increased requirements for specialized expertise not available in-house (\$29,700) and the expert group meetings (\$23,900).

Travel

A total amount of \$103,400 is requested for (a) travel of staff for consultations on issues related to the programme of work, to attend meetings of the relevant bodies of the United Nations and other organizations related to trade and investment, including representation at meetings of WTO, ITC, UNCTAD and ECE; (b) for travel of staff to service the annual Consultative Meetings among the Executive Heads of Subregional Organizations and ESCAP and meetings of regional commodity bodies; and (c) for advisory services on promoting investment opportunities in particular through capital market development. The growth of \$69,100 includes \$46,700 redeployed from the UNCTAD/ESCAP Joint Unit and \$22,400 to meet increased activity levels.

Contractual services

17.29 An estimated amount of \$5,800 is proposed for printing of the *Directory of Trade and Investment Related Organizations of Developing Countries in Asia and the Pacific*, ninth edition.

- 17.30 The work under the subprogramme will be carried out by the Development Research and Policy Analysis Division under the guidance of the Committee on Regional Economic Cooperation, the Committee on Environment and Natural Resources Development and the Committee on Socio-Economic Measures to Alleviate Poverty in Rural and Urban Areas.
- 17.31 The main objectives of the subprogramme are to increase the understanding of the economic and social development situation in the region and to contribute to the awareness and understanding on the part of national policy makers of the constraints to sustained economic growth, poverty alleviation and the integration of environmental concerns into macroeconomic decision- and policy-making processes. Special attention will be paid to the problems of integrating the countries with economies in transition into the region's economic mainstream.
- 17.32 Documentation and substantive services will be provided to the Commission and to the three committees mentioned above. Research and analysis will be carried out and technical assistance will be formulated and implemented with the aim of translating into action the strong desires of the countries of the region to cooperate among themselves to share experiences in practices and policies to tackle common issues.

Activities

- 17.33 During the biennium 1998-1999, the following activities will be undertaken:
 - (a) Servicing of intergovernmental/expert bodies
 - (i) Substantive servicing of meetings. Twelve plenary and 4 committee sessions of the Commission; 2 plenary meetings of the Committee on Regional Economic Cooperation; 2 plenary meetings of the Committee on Environment and Natural Resources Development; 2 plenary meetings of the Committee on Socio-Economic Measures to Alleviate Poverty in Rural and Urban Areas;
 - (ii) Parliamentary documentation
 - a. Commission. Two reports on current economic situation and policy issues;
 - b. Committee on Regional Economic Cooperation. Report on macroeconomic developments, issues and policies;
 - c. Committee on Environment and Natural Resources Development. Report on integrating environmental considerations into economic decision-making;
 - d. Committee on Socio-Economic Measures to Alleviate Poverty in Rural and Urban Areas. Report on economic growth, income distribution and poverty;
 - (iii) Expert group meetings. Two expert group meetings on development issues and policies;
 - (b) Other substantive activities (RB/XB)
 - (i) Recurrent publications. Two issues of *Economic and Social Survey of Asia and the Pacific*; Asia-Pacific Development Journal (biannual); and Development Papers (annual);
 - (ii) Non-recurrent publications. Integrating environmental considerations into economic decision-making; economic governance; macroeconomic dimensions of enhancing collaboration and cooperation among the developing countries of the region, with special reference to countries with economies in transition; and economic growth, income distribution and poverty;
 - (c) International cooperation and inter-agency coordination and liaison (RB/XB). Collaboration with UNCTAD, the Department for Economic and Social Information and Policy Analysis, the Department for Policy Coordination and Sustainable Development, the World Bank and the Asian Development Bank on development issues and policies; and collaboration and liaison with inter-agency committees and intergovernmental and non-governmental organizations in the region working on economic development issues, strategies and policies and on integrating environmental considerations into economic decision-making;

- (d) Technical cooperation (RB/XB)
 - (i) Advisory services. Two advisory missions on modelling and simulation of macroeconomic models, macroeconomic reforms and policy management in the countries with economies in transition, and on integrating environmental considerations into economic decision-making;
 - (ii) Group training (seminars, workshops and symposia). Three seminars on economic governance; integrating environmental considerations into economic decision-making; and economic growth, income distribution and poverty. Workshop on macroeconomic dimensions of enhancing collaboration and cooperation among the countries with economies in transition.

Resource requirements (at current rates)

Posts

An estimated amount of \$2,478,400 would provide for eight Professional and higher level posts and nine Local level posts as shown in table 17.12 above. The staffing requirements to undertake the programme of work outlined in paragraph 17.33 above reflect the outward redeployment of one P-2 post to subprogramme 10, Least developed, landlocked and island developing countries, and the proposed abolition effective 1 January 1999 of one P-3 post and one Local level post. The reduction of \$56,200 reflects the combined effect of the abolition and redeployment of posts and the application of new standardized vacancy rates.

Other staff costs

- 17.35 An estimated amount of \$18,100 is requested for flexible provision of some clerical support functions.
 - Consultants and experts
- 17.36 An estimated amount of \$56,800 reflecting a reduction of \$3,000 is requested as follows: (a) \$39,100 for consultancy services for the preparation of background country papers and analyses on specialized topics for the annual *Economic and Social Survey of Asia and the Pacific* as reflected in paragraph 17.33 (b) (i) above; and (b) \$17,700 for two ad hoc expert group meetings on development issues and policies as reflected in paragraph 17.33 (a) (iii) above.

Travel

17.37 A provision of \$51,400 reflecting a reduction of \$4,400 is proposed for travel of staff to attend meetings of the relevant bodies of the United Nations system, such as the Committee on Development Planning; consultations with the Department for Economic and Social Information and Policy Analysis; and for travel of staff to collect country data and information, and to conduct consultations with authorities in countries of the region on development issues and policies and with other organizations.

Contractual services

17.38 An estimated amount of \$58,600 reflecting a reduction of \$3,700 is requested for printing the *Economic* and Social Survey of Asia and the Pacific, the Asia-Pacific Development Journal and the Development Papers.

- 17.39 The work under this subprogramme will be carried out by the Industry and Technology Division under the guidance of the Committee on Regional Economic Cooperation.
- 17.40 The focus of work under this subprogramme will be to assist countries in the region in policy formulation to accelerate industrial and technological development. Assistance will be rendered to strengthen national capabilities in areas such as capital flows, especially for small and medium-sized enterprises, involvement of women in manufacturing, building up of industrial and technological infrastructure and access to new and emerging technologies. Furthermore, the enhanced participation of the private sector will be encouraged in the development of human resources, focusing on industrial and technological skills creation and upgrading, domestic and foreign direct investment, and policy formulation and review. Assistance will be provided to strengthen the capacity of national institutions in activities related to technology choice, transfer, adaptation and utilization through favourable policy framework and institutional mechanisms. The utilization and development of environmentally sound technologies in industries will be promoted. The activities are also aimed at assisting the least developed, landlocked and island developing countries as well as countries with disadvantaged economies in transition in strengthening their national capabilities to design appropriate policy measures and technical assistance programmes for industrial and technological development in order to bring them into the mainstream of the regional economic development.

Activities

- 17.41 During the biennium 1998-1999, the following activities will be undertaken:
 - (a) Servicing of intergovernmental/expert bodies
 - (i) Substantive servicing of meetings. Twelve plenary and four committee sessions of the Commission; 6 plenary meetings of the Committee on Regional Economic Cooperation; and 12 plenary meetings of its Steering Group;
 - (ii) Parliamentary documentation
 - a. Commission. Two reports on issues related to industry and technology;
 - b. Committee on Regional Economic Cooperation. Report on issues related to industry and technology;
 - Steering Group of the Committee on Regional Economic Cooperation. Two reports on issues related to industry and technology;
 - (iii) Ad hoc expert group meetings. Two ad hoc expert group meetings on industrial complementarities and tripartite cooperation and on development and utilization of science and technology indicators in developing countries of the ESCAP region;
 - (b) Other substantive activities (RB/XB)

 - g. Regional cooperation for the adoption of ISO 14000 Standards;
 - Two workshops on the implications of regional and global agreements on technological development and technology transfer and on strengthening national capabilities in areas of technology transfer and management, consultancy services and standard, meteorology and quality control;
 - i. Meeting on technology cooperation for the development of selected industries, particularly agro- and allied industries;
 - j. Regional/subregional workshop on strengthening the role of small and medium-sized enterprises to alleviate rural poverty in a liberalized economic environment;
 - k. Meeting of the Regional Forum for Promoting Policy Dialogue in Industrial Development and Restructuring.

Resource requirements (at current rates)

Posts

17.42 Estimated requirements of \$2,523,200 would provide for nine Professional and higher level posts and nine Local level posts as shown in table 17.14 above. The staffing requirements to undertake the programme of work outlined above in paragraph 17.41 reflect the abolition of one P-4 and one P-2 posts; while the P-4 post would be proposed for abolition effective 1 January 1998, it is proposed to abolish the P-2 post effective 1 January 1999. The reduction of \$145,500 represents the combined effect of the abolition of these posts and the application of new standardized vacancy rates.

Consultants and experts

17.43 A provision of \$66,500 is requested as follows: (a) \$34,200 for specialized consultancy services not available in the secretariat for the preparation of the following studies and other materials: new technologies on increased competitiveness of manufacturing industries for small and medium-sized enterprises; promoting regional cooperation in utilizing industrial complementarities through tripartite cooperation; new approaches in promoting the sustained participation of women in industrial development; cooperative measures for private sector development, privatization and the enhancement of entrepreneurial capability building; study on the implementation of ISO 14000 Standards; and impact of regional and global agreements on technological development and technology transfer; and (b) \$32,300 for two ad hoc expert group meetings on industrial complementarities and tripartite cooperation and on development and utilization of science and technology indicators in developing countries of the ESCAP region.

Travel

17.44 An estimated provision of \$34,300 is requested for travel of staff to attend the fourth session of the Commission on Science and Technology (1999), to provide advisory services, consult Governments and national institutions on science and technology and to collect data and information on utilization and development of selected environmentally sound technologies by small and medium-sized enterprises; promoting regional cooperation in utilizing industrial complementarities through tripartite cooperation; implementation of ISO 14000 Standards; skills development requirements for industrial and technological competitiveness; and policy formulation for the promotion of technology transfer and technology capability building. The reduction of \$10,400 reflects actual requirements.

Contractual services

17.45 A provision of \$15,600 is requested for printing the publications entitled *Industrial and Technological Development News for Asia and the Pacific* and *Small Industry Bulletin for Asia and the Pacific*.

17.46 The work under the subprogramme will be carried out by the Environment and Natural Resources Management Division under the guidance of the Committee on Environment and Natural Resources Development. The main objective of the subprogramme is to strengthen national capabilities in achieving environmentally sound and sustainable development, focusing on the integration of environment and development policy and sustainable development and management of natural resources.

17.47 Implementation, review and monitoring of the Regional Action Programme for Environmentally Sound and Sustainable Development, 1996-2000 and the recommendations of Agenda 21, together with the outcome of the nineteenth special session of the General Assembly on the implementation of the outcome of the United Nations Conference on Environment and Development, will form the main activities under the environment programme of work. Review of the implementation of relevant international conventions at the regional level, strengthening regional and subregional cooperation and identification of emerging environmental issues will be major areas of activity. Emphasis will be placed on addressing current and emerging issues related to the environment, energy resource options, including rural energy supply, power system planning and management and energy efficiency and conservation. Activities will include analytical and issue-oriented research studies, advisory services and group training. Activities in the mineral resources sector will focus on strengthening the formulation of policies and strategies in the sustainable development of land and mineral resources, including promotion of investment, application of geological aspects in land use and urban planning, and integrated marine policies and assessment and development of non-living marine resources. Activities in the area of water resources will focus on integrated water resources development and management, protection of water resources and water quality and water-related natural disaster reduction in line with the programme of action for sustainable development elaborated in Agenda 21. Activities of space applications will aim at achieving an effective action-oriented regional approach for the implementation of the Beijing Declaration on Space Technology Applications for Environmentally Sound and Sustainable Development in Asia and the Pacific, the Strategy for Regional Cooperation in Space Applications, the Action Plan on Space Applications and the Regional Space Applications Programme for Environmentally Sound and Sustainable Development in Asia and the Pacific, emphasizing technology applications to meet the challenges of natural resources and environment management, natural disaster monitoring and sustainable development planning towards the twenty-first century.

17.48 Preparations will be undertaken during the biennium for the second Ministerial Conference on Space Applications for Sustainable Development in Asia and the Pacific to be held in 1999, for the 2000 Ministerial Conference on Environment and Development and for the publication 2000 State of the Environment in Asia and the Pacific.

Activities

Resource requirements (at current rates)

Posts

17.50 The amount of \$5,707,400 would provide for 23 Professional and higher level posts and 14 Local level posts as shown in table 17.16 above. The staffing requirements reflect the outward redeployment of one P-5 post from this subprogramme to subprogramme 5, Poverty alleviation: social development, and the proposed abolition of two P-4 and two Local level posts (one P-4 and two Local level posts are proposed to be abolished effective 1 January 1999). The reduction of \$256,100 represents the combined effect of the single redeployment and the abolition of four posts and the application of new standardized vacancy rates.

Other staff costs

- 17.51 A provision of \$36,200 would be required for flexible provision of some clerical support functions.

 Consultants and experts
- 17.52 The estimated proposed amount of \$98,100 includes: (a) \$50,000 for specialized consultancy services not available in the secretariat for preparation of the following studies and other materials: implementation of the recommendations of the 1995 Ministerial Conference on Environment and Sustainable Development; preparations for the fourth Ministerial Conference on Environment and Development in Asia and the

Pacific; commercialization of renewable energy technologies and their technology transfer; integration of water resources management in economic and social development plans; working papers in preparation for the Ministerial Conference on Space Applications for Sustainable Development; atlas of mineral resources; mineral concentration and hydrocarbon accumulations; mineral resources assessment, development and management; study on implementation of the Regional Action Programme on Environmentally Sound and Sustainable Development, 1996-2000, and the outcome of the nineteenth special session of the General Assembly; assessment of water resources and water demand by user sectors; ESCAP homepage on energy resources on the World Wide Web; and (b) \$48,100 for the three expert group meetings outlined in paragraph 17.51 (a) (iii) above. The increase of \$11,600 relates to the requirements for the ad hoc expert meetings.

Travel

17.53 A provision of \$79,500 reflecting a decrease of \$18,700 is requested for travel of staff: (a) to attend meetings of the relevant bodies of the United Nations and other organizations related to environment, management of natural resources and space technology applications. These include representation at the Commission on Sustainable Development, the Committee on Natural Resources, the Administrative Committee on Coordination Subcommittee on Water Resources, the Mekong River Commission, inter-agency coordination on space affairs, the Committee on the Peaceful Uses of Outer Space and the Committee on Earth Observation Satellites; (b) to provide advisory services and consult Governments and intergovernmental organizations on implementation of the Regional Action Programme on Environmentally Sound and Sustainable Development, 1996-2000; commercialization of renewable energy technologies and their technology transfer; energy resource options and energy programmes; atlas of mineral resources of the ESCAP region; and mineral resources assessment, mineral resources economics and legislation; and (c) provide services to the Typhoon Committee and the Panel on Tropical Cyclones.

Contractual services

17.54 A provision of \$67,800 is requested for external printing of nine publications.

17.55 The work under this subprogramme will be carried out by the Social Development Division under the guidance of the Committee on Socio-Economic Measures to Alleviate Poverty in Rural and Urban Areas.

17.56 The focus of work under this subprogramme will be to assess and respond to regional trends and challenges in social policy and human resources development, with particular attention to the planning and delivery of social service and training programmes for the poor and other marginalized social groups, including youth, women, disabled persons and older persons. Activities will emphasize strengthening the capacity of the public and non-governmental sectors to develop and implement policies and programmes to enhance the productive and self-help capabilities of the above-mentioned groups as means of enhancing their quality of life. In undertaking this work, attention will be devoted to fostering partnerships between Governments, the private sector, non-governmental organization, and community and other participatory organizations. Priority will be given to activities in regional implementation of global mandates, including the Programme of Action of the World Summit for Social Development and the World Programme of Action for Youth to the Year 2000 and Beyond. Activities will also be in pursuance of the following major regional mandates: Agenda for Action on Social Development in the ESCAP Region; Jakarta Plan of Action on Human Resources Development in the ESCAP Region; and Agenda for Action for the Asian and Pacific Decade of Disabled Persons, 1993-2002.

Resource requirements (at current rates)

Posts

17.58 The staffing resource requirements of \$2,188,000, would provide for nine Professional and higher level posts and five Local level posts as shown in table 17.18. Those requirements reflect the proposed inward redeployment to the subprogramme of one P-5 post from subprogramme 4, Environment and sustainable development to serve as Chief of the Social Policy Section and the abolition of one P-4 post no longer required for the programme of work. The redeployment is aimed at strengthening the capacity of this subprogramme to undertake work in the implementation of the Programme of Action of the World Summit for Social Development and the Agenda for Action on Social Development in the ESCAP Region, as adopted by the Commission in its resolution 51/4. The incumbent would also be responsible for organizing the Asian and Pacific ministerial conferences on social development, which meet every five years, and for conducting surveys of the regional social situation in Asia and the Pacific. The Commission has accorded high priority to this area. At present there is no senior-level post assigned to this function. The growth of \$90,400 represents the combined effect of the single redeployment and the single abolition of one post and the application of new standardized vacancy rates.

Consultants and experts

17.59 The estimated provision of \$60,600 includes: (a) \$47,200 for specialized consultancy services not available in the secretariat for preparation of the following studies and other materials mandated under specific resolutions of the General Assembly and the Commission: report on progress achieved in human resources development through regional cooperation; reports on issues related to the Agenda for Action on Social Development in the ESCAP Region; study on regional networking among centres of excellence for human resources development; study on youth participation indicators; guidelines for the implementation of a regional plan of action for older persons; and (b) \$13,400 for one ad hoc expert group meeting on the Agenda for Action on Social Development in the ESCAP Region, as indicated in paragraph 17.57 (a) (iii) above.

Travel

17.60 A provision of \$80,300 is proposed for travel of staff: (a) to attend meetings of the relevant bodies of the United Nations and other organizations, the Commission on Social Development, the World Conference of Ministers for Youth and the World Youth Forum of the United Nations System related to social development and human resources development, including matters pertaining to youth development; and (b) to provide advisory services and consult Governments, intergovernmental organizations, national centres of excellence and non-governmental organizations on the implementation of the Agenda for Action on

Social Development in the ESCAP Region; implementation of the Jakarta Plan of Action on Human Resources Development in the ESCAP region; regional collaboration among national centres of excellence for human resources development research and training; regional cooperation in human resources development; enhancement of youth skills and promotion of youth participation in development; and design of national youth policy frameworks. The growth of \$42,500 is due to increased regional activities on youth and human resources development in the biennium.

Contractual services

17.61 A provision of \$23,700 is requested for external printing of four publications. The growth of \$13,000 reflects actual requirements.

- - 17.62 The work under the subprogramme will be carried out by the Rural and Urban Development Division under the guidance of the Committee on Socio-Economic Measures to Alleviate Poverty in Rural and Urban Areas.
 - 17.63 The focus of the work under this subprogramme will be to assess regional issues, strengthen the capabilities of grass-roots institutions in rural and urban development and promote policies and programmes on increased gender equality. Analyses of national and regional poverty situation will aim to improve conditions of the target groups through farm and off-farm employment creation and access of poor to land, credit and other productive assets. Activities will emphasize increasing the capacity of governmental and non-governmental organizations to develop innovative ways of rural and urban poverty alleviation, and support food security at the rural household levels. They will promote proper use of agro-chemicals to achieve sustainable agricultural development as well as augment food supply. Assistance will be provided to promote policies and programmes to enable women to play an active role as both agents and beneficiaries of development. Activities will also be pursued as a follow-up to the Jakarta Declaration and Plan of Action for the Advancement of Women in Asia and the Pacific and the Beijing Declaration and Platform for Action; and the Regional Action Plan on Urbanization and the Habitat Agenda.

Workshops as follows: one on integrated pest management in rural poverty alleviation; one on economic aspects of non-chemical crop protection; seven on policy analysis on food security, rural credit and rural institutions; four on environmentally friendly plant nutrition concepts; three on fertilizer marketing training; two on plant nutrition surveys; one on emerging urban issues; and one on innovative approaches to urban governance;
 - d. Seminars as follows: two on fertilizer policy issues; two on poverty alleviation for women; two on women's rights, violence against women and trafficking; and one on enhancing women's participation in decision-making and governance;

Resource requirements (at current rates)

Posts

17.65 Resource requirements of \$2,912,300 would provide for 11 Professional and higher level posts and 6 Local level posts as shown in table 17.20 above. These staffing requirements reflect the redeployment inwards of one Local level post from the subprogramme Executive direction and management and the proposed abolition effective 1 January 1999 of two Professional posts (one D-1 and one P-3) and one Local level post. The resource requirements represent the combined effect of the abolition and redeployment of these posts, the delayed impact of one P-5 post established in the biennium 1996-1997, and the application of new standardized vacancy rates.

Other staff costs

17.66 A provision of \$18,100 is requested for flexible provision of some clerical support functions.

Consultants and experts

17.67 An estimated provision of \$32,400 reflecting a reduction of \$17,600 is requested as follows: (a) \$20,000 to cover specialized consultancy services not available in the secretariat for preparation of reports on issues related to rural and urban development and background papers on the review of implementation of the Jakarta Declaration and Plan of Action for the Advancement of Women in Asia and the Pacific and the Beijing Declaration and Platform for Action; (b) \$12,400 for the one ad hoc expert group meeting shown in paragraph 17.64 (a) (iii) above.

Travel

17.68 An estimated provision of \$49,900 is proposed for travel of staff: (a) to attend meetings of the relevant bodies of the United Nations and other organizations related to agriculture and rural development, women-in-development and human settlements, including representation at the Centre on Integrated Rural Development for Asia and the Pacific (CIRDAP), the Habitat Commission, the Commission on the Status of Women, and the Administrative Committee on Coordination Inter-agency Meeting on Women and Gender Equality; (b) to provide advisory services and consult governments, local officials and experts on rural development; implementation of the Regional Action Plan on Urbanization and the Habitat Agenda; emerging urban issues; innovative approaches to urban governance; and implementation of the Jakarta Declaration and Plan of Action for the Advancement of Women in Asia and the Pacific and the Beijing Declaration and Platform for Action.

Contractual services

17.69 A provision of \$28,100 is requested for the external printing of six publications.

- 17.70 The work under the subprogramme will be carried out by the Population Division under the guidance of the Committee on Socio-Economic Measures to Alleviate Poverty in Rural and Urban Areas.
- 17.71 The activities under the subprogramme will focus on technical cooperation and research in the areas of ageing, female migration and reproductive health. The growth of \$4,900 represents the combined effect of the abolition of the posts and the application of new standardized vacancy rates.

Other staff costs

17.74 A provision of \$18,100 is requested for the flexible provision of some clerical support functions.

Consultants and experts

17.75 An estimated provision of \$26,000 is proposed as follows: (a) \$9,700 for specialized consultancy services not available in the secretariat for preparation of background papers on appropriate technology for accessing population information and on globalization and population change; and (b) \$16,300 for two ad hoc expert group meetings on appropriate technology for accessing population information and on globalization and population change as indicated in paragraph 17.72 (a) (iii) above.

Travel

17.76 A decreased provision of \$29,000 is proposed for: (a) travel of staff to attend the sessions of the Commission on Population and Development; and (b) travel of staff to provide advisory services on the implementation of the Bali Declaration on Population and Sustainable Development and the Programme of Action of the International Conference on Population and Development; reproductive health and family planning; and population information development.

Contractual services

17.77 A provision of \$16,300 is requested for printing the *Asia-Pacific Population Journal* and the *ESCAP Population Data Sheet*.

- 17.78 The work under this subprogramme will be carried out by the Transport, Communications and Tourism Division under the guidance of the Committee on Transport, Communications, Tourism and Infrastructure Development.
- 17.79 The focus of the work under this subprogramme will be to implement activities under the regional action programme of the New Delhi Action Plan on Infrastructure Development in Asia and the Pacific, prioritized and endorsed by the Ministerial Conference on Infrastructure held at New Delhi in October 1996. These activities are aimed at improving the planning process in developing infrastructure facilities and services at all levels, as well as the efficiency of its administration, management and operation in the countries of the region. Efforts will be made to enhance private sector involvement in national infrastructure development through financing, management, operations and risk-sharing, with a view to accelerating the provision of infrastructure required to sustain the economic and social growth processes. Development of interregional and intra-regional transport linkages to enhance international trade and tourism will be undertaken through the implementation of the Asian Land Transport Infrastructure Development (ALTID) project. To facilitate integrated land-cum-sea transport, activities on freight forwarding and multimodal transport will be undertaken through close cooperation with other international organizations. With a view to increasing safety and safe working practices in transport and communication operations and to reducing

the adverse environmental impact of provision of infrastructure facilities and services to acceptable levels, assistance will be provided to member countries in promoting the safe transport of passengers and goods, particularly hazardous goods, while maintaining a clean environment, and implementing environmental impact assessments in relation to infrastructure development and operation. Assistance will also be provided to developing countries in promoting more equitable spatial distribution of economic activities and easier access to social amenities with the aim to alleviate poverty in the region. Activities will also be aimed at improving policies for planning tourism development, strengthening national capabilities in the development of human resources in the tourism sector and, in particular, tourism marketing; minimizing the environmental impact of tourism; and promoting tourism investment and facilitation of travel.

 - (iii) Organization and servicing of the Regional Inter-Agency Committee for Asia and the Pacific Subcommittee on Infrastructure Development in Asia and the Pacific;
- (d) Technical cooperation (RB/XB)
 - (i) Advisory services. Advisory missions as follows: one on prospects for shipping and port development; two on implementation of comprehensive and integrated approach to policy development in the field of infrastructure, traffic and transport for sustainable environment, mobility and access; one on participatory planning of rural infrastructure; two on promotion of private sector participation in infrastructure development; two on multimodal transport, freight forwarding and facilitation of maritime traffic; one on transportation of dangerous goods; two on financial economic planning of infrastructure and project investment; and two on strengthening national capabilities in tourism development;
 - (ii) Group training (seminars, workshops and symposia)
 - Seminars/workshops as follows: two on transport infrastructure development and facilitation; one on networking of centres of excellence in infrastructure; and one on tourism planning and development;
 - b. Two country-level workshops on road maintenance;
 - Two training workshops on implementation of comprehensive and integrated approach to
 policy development in the field of infrastructure, traffic and transport for sustainable
 environment, mobility and access;
 - d. Regional seminars on infrastructure pricing and on facilitation of travel;
 - e. Symposium on private sector involvement in infrastructure development;
 - f. Subregional seminar on participatory planning of rural infrastructure;
 - g. Training workshop on integration of non-motorized transport in the urban transport system;
 - h. Training seminar on transportation of dangerous goods;
 - i. Workshop on financial economic planning and evaluation of inland waterways transport projects;
 - j. Two meetings on promotion of tourism in the Greater Mekong subregion;
 - k. Regional meeting on promotion of cooperation among tourism training institutes and organizations.

Resource requirements (at current rates)

Posts

17.81 The estimated resource requirements of \$4,004,000 would provide for 16 Professional and higher level posts and 10 Local level posts as shown in table 17.24 above. These requirements reflect the proposed abolition of two P-3 posts and one Local level post (one P-3 post and the Local level post are proposed for abolition effective 1 January 1999) not required to fulfil the programme of work. The reduction of \$20,300 represents the combined effect of the abolition of these posts and the application of new standardized vacancy rates.

Other staff costs

17.82 A provision of \$18,100 is requested for flexible provision of some clerical support functions.

Travel

17.83 An estimated provision of \$45,600 would be required for travel of staff: (a) to attend meetings of the relevant bodies of the United Nations and other organizations related to the transport, communications and tourism, including representation at the General Assembly of the World Tourism Organization, and meetings of the APEC Transportation Working Group and the Asia Infrastructure Development Alliance; and (b) to consult national Governments, intergovernmental organizations and the relevant bodies of the United Nations on the implementation of Commission resolution 52/9 on Intra-Asia and Asia-Europe land bridge, the implementation of the New Delhi Action Plan on Infrastructure Development and the development of a database on infrastructure in the Asian and Pacific region.

Contractual services

17.84 A provision of \$2,900 is requested for the printing of the annual *Transport and Communications Bulletin for Asia and the Pacific*.

- 17.85 The work under the subprogramme will be carried out by the Statistics Division under the guidance of the Committee on Statistics.
- 17.86 The focus of work will be to organize group training and provide advisory services in priority areas, including national accounts statistics and other economic statistics, gender statistics, population censuses and surveys, environment statistics and accounting and management of statistical services. Those activities will be implemented in coordination with relevant global, regional and subregional statistical entities.
- 17.87 The growing competencies of the member States in contributing to statistical capability-building will be taken into account in the modalities of regular and extrabudgetary activities. Regional-level coordination will be undertaken in the development, revision, testing and implementation of selected international statistical standards and, where necessary, their adaptation to meet the conditions and needs of the countries of the region.
- 17.88 Comparable socio-economic statistics will be disseminated through modern recurrent publications and off-line and on-line electronic media. The use of electronic technology will be increased in the acquisition of data with the aim of improving timeliness and accuracy of published statistics and of reducing the response burden of reporting statistical offices. ESIS will be improved in line with industry standards and as an integral part of the overall information system of ESCAP. Senior-level public decision makers will be trained in effective management of information technology, including strategic policy formulation.

- 17.89 During the biennium 1998-1999, the following activities will be undertaken:
 - (a) Servicing of intergovernmental/expert bodies
 - (i) Substantive servicing of meetings. Twelve plenary and 4 committee sessions of the Commission; and 6 plenary meetings of the Committee on Statistics;
 - (ii) Parliamentary documentation
 - a. Commission. Report on issues related to statistics and report of the Committee on Statistics;
 - b. Committee on Statistics. Report of the Working Group of Statistical Experts; and reports on selected issues related to statistical development, issues in computerization in the public

sector, an integrated presentation of work programmes on statistics in the region and activities of the secretariat since the tenth session of the Committee;

- (iii) Expert group meetings. One Working Group Meeting of Statistical Experts;
- (b) Other substantive activities (RB/XB)
 - (i) Recurrent publications. Eight issues of the Statistical Newsletter; four issues of the Government Computerization Newsletter; Annual Statistical Yearbook for Asia and the Pacific; Annual Foreign Trade Statistics for Asia and the Pacific; eight issues of Statistical Indicators for Asia and the Pacific; Annual Asia-Pacific in Figures; and three issues of the newsletter on information technology applications in population statistics;
 - (ii) Non-recurrent publications. Three methodological guidelines on statistics;
 - (iii) Electronic, audio and video issuances. ESCAP homepage on statistics on the World Wide Web;
 - (iv) Exhibits. Exhibit for the Committee on Statistics;
 - (v) Two wall charts on general/thematic statistics;
 - (vi) Technical material for outside users (databases, software, etc.). Data disseminated on electronic media (CD-ROM, diskettes etc.); operation and maintenance of ESIS; responses to ad hoc requests from outside users for statistical information;
- (c) International cooperation and inter-agency coordination and liaison (RB/XB)
 - (i) Cooperation and collaboration, as relevant, with United Nations bodies and specialized agencies, including the United Nations Statistical Commission and the Working Group Meeting of Statistical Experts, regional conferences of statisticians and FAO Asia and Pacific Commission on Agricultural Statistics; the Administrative Committee on Coordination Subcommittee on Statistical Activities; intergovernmental organizations outside the United Nations system, including the East-West Centre and SPC, and non-governmental organizations, including the International Statistical Institute;
 - (ii) Technical and substantive support to UNFPA Country Support Teams in the region and to the Statistical Institute for Asia and the Pacific;
- (d) Technical cooperation (RB/XB)
 - (i) Advisory services. Advisory missions as follows: five on statistics on gender issues and other aspects of socio-economic statistics and indicators and two on statistical organization and management, and application of information technology, including in the public sector;
 - (ii) Group training (seminars, workshops and symposia). Regional/subregional workshops as follows: two on population and social statistics, including the follow-up to global social conferences; four on economic statistics, including national accounts; three on environmental statistics and accounting; and two on statistical organization and management, and application of information technology, including in the public sector.

Resource requirements (at current rates)

Posts

17.90 The estimated resource requirements of \$2,476,100 would provide for 8 Professional and higher level posts and 13 Local level posts as shown in table 17.26 above. These requirements reflect the proposed onward redeployment of one Local level post from the subprogramme to subprogramme 10, Least developed, landlocked and island developing countries, and the abolition of one Local level post. The growth of \$136,700 represents the combined effect of the abolition and redeployment of these posts and the application of new standardized vacancy rates.

Consultants and experts

17.91 An estimated provision of \$25,300 is requested as follows: (a) \$16,500 for specialized consultancy services not available in the secretariat for preparation of the following publications and technical materials:

Statistical Yearbook for Asia and the Pacific; Foreign Trade Statistics for Asia and the Pacific; Statistical Indicators for Asia and the Pacific; Asia-Pacific in Figures; for operation and maintenance of ESIS; and for responses to ad hoc requests from outside users for statistical information; and (b) \$8,800 for the Working Group Meeting of Statistical Experts shown in paragraph 17.89 (a) (iii) above.

Travel

17.92 A reduced provision of \$44,700 is proposed for travel of staff to attend meetings of the relevant bodies of the United Nations and other organizations related to statistics. These include representation at the United Nations Statistical Commission and the Working Group on International Statistical Programmes and Coordination.

Contractual services

17.93 An estimated provision of \$44,400 is requested for the external printing of five publications and wall charts.

- 17.94 The work under this subprogramme will be carried out by the Least Developed Countries Section of the Development Research and Policy Analysis Division and the ESCAP Pacific Operations Centre under the guidance of the Special Body on Least Developed and Landlocked Developing Countries and the Special Body on Pacific Island Developing Countries.
- 17.95 The focus of work will be to highlight trends and emerging problems and draw policy makers' attention to priority concerns and to improve the capacities of least developed, landlocked and island developing countries to integrate more closely into the dynamic regional development as well as into the international economy. Particular attention will be given to support their efforts at economic reform and more efficient resource mobilization and use, as well as to secure greater participation in the growing intraregional flows of investment. Priority will be given to activities in regional implementation of the Programme of Action for the Least Developed Countries for the 1990s and in the Programme of Action for the Sustainable Development of Small Island Developing States. Human resources development, especially developing the skills of public officials in the areas of macroeconomic policy formulation will be emphasized.

- 17.96 During the biennium 1998-1999, the following activities will be undertaken:
 - (a) Servicing of intergovernmental/expert bodies
 - (i) Substantive servicing of meetings. Twelve plenary and 4 committee sessions of the Commission; 2 informal meetings of the Commission on least developed countries, Pacific island developing countries and economies in transition; 4 plenary meetings of the Special Body on Least Developed and Landlocked Developing Countries; and 4 plenary meetings of the Special Body on Pacific Island Developing Countries;
 - (ii) Parliamentary documentation
 - a. Commission. Reports of the Special Body on Least Developed and Landlocked Developing Countries and of the Special Body on Pacific Island Developing Countries;
 - b. Commission on Sustainable Development. Report on follow-up to the Programme of Action for the Sustainable Development of Small Island Developing States;

- c. Special Body on Least Developed and Landlocked Developing Countries. Two reports on issues related to least developed and landlocked developing countries;
- d. Special Body on Pacific Island Developing Countries. Two reports on issues related to Pacific island developing countries;
- (b) Other substantive activities (RB/XB). Non-recurrent publications. Review of implementation of the Programme of Action for the Least Developed Countries for the 1990s; enhancing cooperation in trade and investment between Pacific island countries and economies of East and South-East Asia; and options for exchange-rate policy in least developed countries;

Resource requirements (at current rates)

Posts

17.97 The estimated requirements of \$1,472,000 would provide for seven Professional and higher level posts and one Local level post as shown in table 17.28 above. These requirements reflect: (a) the redeployment to this subprogramme of one P-2 post from subprogramme 2, Regional economic cooperation: research and policy analysis, to strengthen the capacity of this subprogramme to undertake research work, including follow-up to the Programme of Action for the Sustainable Development of Small Island Developing States, and of one Local level post from subprogramme 9, Statistics, to strengthen the administrative support service of ESCAP Pacific Operations Centre at Port Vila, Vanuatu; and (b) the abolition of one Local level post in Bangkok effective 1 January 1999.

Other staff costs

17.98 A provision of \$18,100 is requested for flexible provision of some clerical support functions.

Consultants and experts

17.99 An estimated provision of \$14,700 would be required to cover specialized consultancy services not available in the secretariat for the preparation of: (a) two reports on the specific themes to be selected by the Special Body on Least Developed and Landlocked Developing Countries at its third and fourth sessions (1997 and 1998, respectively) for presentation to its fourth and fifth sessions, respectively; and (b) working papers for the review of the implementation of the Programme of Action for the Least Developed Countries for the 1990s.

Travel

17.100 An increased provision of \$66,600 would be required for travel of staff: (a) to attend meetings of the UNCTAD Trade and Development Board, the Commission on Sustainable Development, and other relevant intergovernmental bodies such as SPREP, and (b) to consult Governments and intergovernmental

organizations on implementation of the Programme of Action for the Least Developed Countries for the 1990s; macroeconomic reforms and sustainable development issues for the Pacific island developing countries; and promotion of sustainable development in small island developing States.

17.101 Programme support comprises programme management, information services, conference services and administration and common services.

- 17.102 During the biennium 1998-1999, the following activities will be undertaken:
 - (a) Programme management. The Programme Management Division provides substantive and secretariat services to the Commission and its subsidiary bodies as well as to meetings of the Advisory Committee of Permanent Representatives and Other Representatives Designated by Members of the Commission. It coordinates the planning, programming and implementation of the work programme of the Commission, including its programme of technical cooperation activities in accordance with the mandates of the Commission and the United Nations global bodies. In addition, the Division assists and advises the Executive Secretary in establishing coherent policy and strategic guidelines on programme planning and the operational activities of ESCAP, as well as on the mobilization, management and use of regular and extrabudgetary resources, based on assessments of emerging regional and subregional needs;
 - (i) Servicing of intergovernmental and expert bodies (RB/XB)
 - a. Substantive servicing of meetings. Substantive servicing of the Commission sessions and organization and servicing of the monthly sessions of the Advisory Committee of Permanent Representatives and Other Representatives Designated by Members of the Commission;
 - b. Parliamentary documentation. Reports on implementation of the programme of work of the Commission for 1998-1999; proposed biennial programme of work, 2000-2001; proposed revisions to the medium-term plan for the period 1998-2001; proposed medium-term plan beyond 2001; implementation of the programme of work for 1996-1997; annual report on technical cooperation activities of ESCAP and extrabudgetary contributions; annual report on the implementation of Technical Cooperation among Developing Countries; and biennial report to the High-level Committee on the Review of Technical Cooperation among Developing Countries in New York;

- (ii) International cooperation and inter-agency coordination and liaison (RB/XB)
 - a. Identification of the possible areas of cooperation and coordination between the ESCAP work
 programme and those of other organizations of the United Nations system, including
 organization and servicing of the Regional Inter-Agency Committee for Asia and the Pacific,
 and appropriate external regional institutions;
 - b. Coordination of the preparation of ESCAP inputs to global intergovernmental and inter-secretariat bodies of the United Nations and its system;
 - c. Liaison with UNDP, UNFPA, the United Nations International Drug Control Programme and other relevant organizations to coordinate and harmonize the regional operational programmes of ESCAP with those at the country levels;
- (iii) *Technical cooperation (RB/XB)*. Two workshops on national focal points for technical cooperation among developing countries and management of the Supplementary Fund for technical cooperation among developing countries;
- (iv) Administrative support services (RB/XB). Activities include overall coordination of programme planning, budgeting, monitoring and evaluation services to the Commission and other meetings, collaboration with other entities and organizations of the United Nations system and appropriate outside institutions, mobilization of extrabudgetary resources and management of technical cooperation activities;
- (b) *Information services*. Activities include full coverage of the work of the Commission and its secretariat. They include preparing press releases, summaries of proceedings and debates, special brochures, booklets, wall charts, information kits, films, videotapes, briefings and exhibitions and library services;
- (c) Conference services. Activities include the provision of conference services to meetings of the policy-making organs and other intergovernmental meetings held under the auspices of ESCAP, and translation and printing of documents and publications;
- (d) Administration and common services. These services relate to human resources management, financial administration and resource planning, and use of common services to support the implementation of the work programme. Activities include (a) recruitment, placement, career development, staff training, staff administration, staff counselling and medical services; (b) financial management, control and treasury services; (c) general services, including buildings management, security and safety, communications, procurement, transportation; and (d) electronic data-processing services.

Resource requirements (at current rates)

Posts

17.103 The estimated resource requirement of \$26,922,500 would provide for 57 Professional and higher level posts and 1 Field Service and 207 Local level posts as shown in table 17.30 above. These requirements reflect the abolition of 4 P-3, 1 P-2, 2 Field Service and 22 Local level posts (1 P-3, 1 P-2 and 7 Local level posts are proposed to be abolished effective 1 January 1999) no longer required as a result of improved working methods for the provision of support services. The reduction of \$714,500 represents the combined effect of the abolition of these posts and the application of new standardized vacancy rates.

Other staff costs

17.104 The estimated requirements of \$842,500 would provide for the following: (a) \$283,100 for general temporary assistance during periods of peak workload and to cover the replacement of staff on extended sick leave and maternity leave; (b) \$248,500 for overtime in periods of peak workload and night differential; and (c) \$310,900 for contractual security, a part-time human resources/staff counsellor in response to recommendations of the Office of Human Resources Management and the Staff-Management Coordination Committee and other clerical services.

Travel

17.105 The reduced requirements of \$68,500 relate to (a) travel for consultations at Headquarters, with ESCAP institutes and ESCAP Pacific Operations Centre at Port Vila, Vanuatu, on programme coordination and administrative, financial and personnel matters; and (b) travel of Conference Services staff to attend the annual sessions of the Inter-agency Meeting on Language Arrangements, Documentation and Publications and the Joint Inter-Agency Meeting on Computer-assisted Translation and Terminology.

Contractual services

17.106 The estimated requirements of \$237,400 relate to language training; other specialized training such as Security and Safety; external printing of publications exempt from the Publications Board such as A Profile of ESCAP, quarterly United Nations Asia-Pacific news, United Nations Focus, booklets, brochures and leaflets; public information production costs, such as professional assistance for photographic production, audio-visual film production preparation and mounting of exhibition materials; annual contract for software support and maintenance services covering operating system and systems software; upgrading of existing system administration, application development and user-oriented software tools; contractual design and development of software for ready access of ESCAP data and information through CD-ROM; and contractual revision and augmenting of modules comprising ESIS to add new features and rectify deficiencies.

General operating expenses

17.107 The proposed resources of \$4,695,000, which reflect a reduction of \$48,300, is comprised of the following requirements: (a) \$1,389,500 for rental and maintenance of premises, reduced by \$51,400; (b) \$1,810,300 for utilities (electricity, water, fuel and oil), reduced by \$17,900; (c) \$205,200 for rental of photocopying equipment and vehicles, increased by \$76,800; (d) \$59,400 for rental and maintenance of data-processing equipment, increased by \$22,400; (e) \$743,400 for communications (postage, cables, telephone, telex and pouch) at maintenance level; (f) \$315,000 for maintenance of furniture and equipment, including *inter alia* ESCAP's share of the maintenance and support of the local area network (LAN) technical infrastructure (including central servers) necessary for the support of central management servers such as 3-main, UNIX for IMIS, etc., increased by \$205,300; and (g) \$172,200 for miscellaneous services including freight, general insurance, bank charges and other services, reduced by \$184,300.

Hospitality

17.108 The estimated amount of \$14,400, at the maintenance level, would provide for official functions in the context of the sessions and/or meetings of intergovernmental bodies as well as for the celebration of United Nations Day.

Supplies and materials

17.109 An estimated amount of \$798,500 is requested for office supplies and materials, internal reproduction supplies, library books and supplies and public information supplies.

Furniture and equipment

17.110 An estimated provision of \$1,223,700, reflecting a decrease of \$287,100, is requested as follows:

(a) \$42,500 for replacement of office furniture and equipment; (b) \$840,700 for acquisition and replacement of automation equipment and related software; (c) \$155,600 for replacement of printing equipment and of conference-servicing equipment; (d) \$58,800 for transportation equipment; (e) \$54,200 for communications equipment; and (f) \$71,900 for other equipment, including building maintenance, security and safety, and miscellaneous equipment such as drinking water cooler units, lockers for buildings maintenance staff, etc.
