<u>Letter dated 24 June 1997 from Mr. Osman Ertuğ addressed</u> <u>to the Secretary-General</u>

Upon instructions from my Government, I have the honour to respond to a letter dated 19 June 1997 addressed to you by the Greek Cypriot representative at the United Nations concerning the recent visit to ports in the Turkish Republic of Northern Cyprus by ships belonging to the Turkish Navy (A/51/928-S/1997/476).

I wish to stress, in this connection, that any visit by ships of the Turkish Navy to Turkish Cypriot ports is a matter which concerns the Turkish Republic of Northern Cyprus and Turkey, as two sovereign, independent States which recognize each other. The Greek Cypriot administration of Southern Cyprus has no say in this matter, as it has no control or jurisdiction over the territorial waters, land or airspace of the Turkish Republic of Northern Cyprus.

As far as the military and political implications of the matter are concerned, the allegations made by the Greek Cypriot side are clearly unwarranted and totally hypocritical. The following list of visits to Southern Cyprus by warships of the Greek Navy in the last three years will amply demonstrate this point:

Furthermore, in the framework of the so-called "joint defence doctrine" between Southern Cyprus and Greece, the Greek Cypriot administration is constructing a naval base for Greece at Limassol, in addition to an air force base at Paphos. As is well known, the Greek Cypriot side has also purchased the sophisticated S-300 missile system from the Russian Federation, as part of its campaign of militarization, on which it is spending over \$2 million per day.

In view of the above, the Greek Cypriot allegations in regard to visits by Turkish ships to ports within the Turkish Republic of Northern Cyprus clearly constitute another instance of the campaign of propaganda being carried out by the other side without any regard to the need for the suspension of such harmful rhetoric, particularly on the eve of the upcoming direct talks between the two leaders in New York, and the creation of an atmosphere conducive to progress towards a viable and just settlement.

I should be grateful if the text of the present letter could be circulated as a document of the General Assembly, under agenda item 58, and of the Security Council.
