In view of the very full agenda and in the light of past experience a preliminary discussion of the documents concerning portable tanks (item 3(b)) by a working group may be desirable. Several experts have suggested that the first two days would be the most suitable time and the Committee is expected to take a decision on this matter at the beginning of its deliberations.

Depending on the progress made on items 5 to 8 on 9 and 10 December, the Committee may have to meet in the afternoon of 10 December.
