**RESOLUTIONS OF THE ECONOMIC AND SOCIAL COUNCIL AND  
THE GENERAL ASSEMBLY RELEVANT TO THE WORK OF ECE**

Note by the Executive Secretary

Each year ECE contributes to reports requested by the Economic and Social Council (ECOSOC) and the General Assembly. Pursuant to resolutions/decisions adopted by ECOSOC at its 1995 and 1996 sessions, ECE will prepare three reports and contribute to the preparation of 16 reports to be submitted to the 1997 session. At the time of preparation of this note, requests deriving from the fifty-first session (1996) of the General Assembly for reports to be submitted to the Assembly's fifty-second session had not been communicated. However, it is to be noted that ECE prepared one report and contributed to 16 reports submitted to the fifty-first session of the Assembly.

This requires considerable time. In the context of global reform, member countries may wish to give consideration to streamlining the reporting mechanism and to the effective use of these reports.

1. This note provides summary information on the relevant resolutions adopted by ECOSOC and the General Assembly since the fifty-first session of the Commission which have required or will require action by the Commission.

2. The attention of member countries is drawn to the fact that requests from ECOSOC and the General Assembly demand significant coordination and drafting time by the Office of the Executive Secretary as well as the time of the Divisions.

3. Thus far, these reports do not seem to have been used fully in the information and coordination mechanisms at the global level. Since the regional commissions are at the cross-roads between a top-down and a bottom-up approach, these reports should be conceived first as instruments which convey to other regions or global entities the achievements of ECE which could be of interest to them. Secondly, the reports should demonstrate how ECE discharges intergovernmental mandates adopted at the global level.

#### REPORTS PREPARED BY ECE

4. ECE reports directly each year to ECOSOC. In addition to submitting its own report, in 1997, it is expected that the Commissions will be requested to report on the follow-up to world Conferences and on reform in the Commissions.

5. Pursuant to ECOSOC decision 1996/301, ECE will also prepare a report on the periodicity of amendments to the recommendations on the transport of dangerous goods. In this connection, it should be noted that ECOSOC endorsed, at its resumed session in November 1996, the full membership of Australia and Spain in its Committee of Experts. As requested by ECOSOC resolution 1995/48, ECE and ECA will prepare a report on the Europe/Africa permanent link through the Strait of Gibraltar.

6. ECE prepared, in cooperation with all concerned entities of the United Nations system, the World Bank and the IMF, the report of the Secretary-General on the Integration of economies in transition into the world economy. Pursuant to resolution 49/106, this report was presented to the General Assembly at its fifty-first session. A similar report will be prepared for the fifty-third session in 1998.

#### INPUTS PROVIDED BY ECE FOR THE PREPARATION OF REPORTS

7. ECE has been requested to provide inputs to 17 reports for the 1997 session of ECOSOC (see Annex I). At the time of preparation of this note, requests deriving from the fifty-first session (1996) of the General Assembly for reports to be submitted to the Assembly's fifty-second session had not been communicated, however it should be noted that ECE prepared one report and contributed to 16 others submitted to the fifty-first session of the Assembly (Annex II).

#### OTHER ACTIVITIES

8. In addition to the preparation of reports, a number of resolutions call for follow-up action or specific activities. For example, Assembly resolutions concerning follow-up to United Nations global conferences and Summits have requested the regional commissions to strengthen the inter-agency consultative arrangements at the regional level so as to develop regional monitoring and other activities in support of objectives set forth by the UN global conferences.

9. Assembly resolution A/51/L.55 on the Implementation of the World Summit for Social Development renewed the invitation to the regional commissions, within their mandates and in cooperation with the regional intergovernmental organizations and banks, to convene on a biennial basis a meeting at a high political level to review the progress made. The General Assembly welcomed the invitation of the Government of Austria to host a regional follow-up meeting in Vienna at the beginning of 1998. The ECE will hold consultations to ascertain its role in the organization of this meeting.

10. Assembly resolution 50/107 on the Eradication of poverty proclaimed 1996 as the International Year of the Fight Against Poverty, as well as the First UN Decade for the Eradication of Poverty. ECE marked the International Year by organizing in November 1996, in cooperation with the American Association of Retired Persons and the United Nations Population Fund, a workshop devoted to social protection, poverty and older persons at risk. The recommendations of the workshop were reported to ECOSOC through the Commission on Social Development.

11. Many other Assembly resolutions, such as that relating to cooperation with the business community, are relevant to the work of ECE although they do not specifically mention the regional commissions. Accordingly, the ECE secretariat monitors Assembly resolutions in order to take the appropriate action and, as mentioned above, to provide as required substantive inputs for reports by the Secretary-General.
