International Covenant on Economic, Social and Cultural Rights: Status as at 31 January 1997



International Covenant on Civil and Political Rights: Status as at 31 January 1997



Optional Protocol to the International Covenant on Civil and Political Rights



Second Optional Protocol to the International Covenant on Civil and Political Rights



International Convention on the Elimination of All Forms of Racial Discrimination: Status as at 31 January 1997




Convention on the Rights of the Child: Status as at 31 January 1997



Human rights field activities: status as at 1 January 1997



Ongoing and projected technical cooperation activities



( as at 31 January 1997)



( as at 31 January 1997)


