- Note 1:** The deadline for submission of proposals is 25 April 1997. Documents must be received at the latest on that date in paper form or electronic diskette form (or via E.mail services). The quality of fax transmission is not suitable for reproduction; therefore documents received by 25 April in the form of fax messages only will not be considered as documents received in due time.
- Note 2:** For planning purposes, authors of proposals are invited to inform the secretariat at the latest by 11 April 1997 of the number of documents they intend to submit and the expected number of pages for each document.
- Note 3:** Submissions should be concise and as short as possible; they should include a justification. The number of proposals in a single document should be limited; they should all relate to the same subject under one agenda item.
- Note 4:** The morning and afternoon sessions on 15 July will be reserved for the working group on the harmonization of classification criteria (physical hazards). This group is convened in the context of global harmonization of classification of criteria, cooperation with the International Labour Organization (ILO) and the Inter-Organization Programme on Sound Management of Chemicals (IOMC) and follow-up to the United Nations Conference on Environment and Development (UNCED). Therefore this group should be composed of experts familiar with transport legislation and other relevant legislations (work safety, environment, consumer protection).
- Note 5:** An annotated agenda will be circulated at a later stage on the basis of proposals received by 25 April 1997.
