## RESOLUTION ADOPTED BY THE GENERAL ASSEMBLY

[without reference to a Main Committee (A/50/L.53/Rev.1)]

50/86. The situation of democracy and human rights in Haiti

The General Assembly,

<u>Having considered further</u> the item entitled "The situation of democracy and human rights in Haiti",

 $\underline{\text{Recalling}}$  all its relevant resolutions, as well as those adopted on the question by the Security Council, the Economic and Social Council and the Commission on Human Rights,

<u>Recalling also</u> the relevant resolutions adopted on the question by the Organization of American States,

<u>Reaffirming</u> that the goal of the international community remains the full observance of human rights and fundamental freedoms and the promotion of social and economic development in Haiti,

<u>Welcoming</u> the legislative and municipal elections being held in a peaceful environment and observed by the Organization of American States in close coordination with the United Nations,

<u>Stressing</u> the willingness of the Government of Haiti to hold the forthcoming presidential elections in accordance with the Constitution, as a crucial step in the complete consolidation of long-lasting democracy in Haiti,

<u>Strongly supportive</u> of the continuing leadership of the Secretary-General of the United Nations and the Secretary-General of the Organization of American States in the efforts of the international community in furthering political progress in Haiti,

<u>Welcoming</u> the success of the United Nations Mission in Haiti and the contributions of the Special Representative of the Secretary-General of the United Nations and his staff to that success,

<u>Welcoming also</u> the continued efforts by States to provide humanitarian assistance and technical cooperation to the people of Haiti,

<u>Supporting fully</u> the contribution of the International Civilian Mission to Haiti and the United Nations Mission in Haiti in the establishment of a climate of freedom and tolerance propitious to the full observance of human rights and the full restoration of the constitutional democracy of Haiti,

<u>Paying tribute</u> to the members and staff of the International Civilian Mission to Haiti for their contribution in accompanying the Haitian people in their efforts to return to constitutional order and democracy,

 $\underline{\text{Welcoming}}$  the continuous improvement in the situation of human rights in Haiti,

Taking note of the report of the Secretary-General of 12 October 1995 on the situation of democracy and human rights in Haiti,  $\underline{1}$ /

- 1. Welcomes the report of the Secretary-General, outlining the continuation until 7 February 1996 of the joint participation of the United Nations with the Organization of American States in the International Civilian Mission to Haiti, with the task of verifying full observance by Haiti of human rights and fundamental freedoms, in order to further the establishment of a climate of freedom and tolerance propitious to the consolidation of long-term constitutional democracy in Haiti and to contribute to the strengthening of democratic institutions;
- 2. <u>Stands ready</u>, upon consideration of a recommendation by the Secretary-General and at the request of the Haitian authorities, to extend the United Nations component of the International Civilian Mission to Haiti beyond 7 February 1996 in an appropriate resolution;
- 3. <u>Expresses its full support</u> for the International Civilian Mission to Haiti and trusts that the Government of Haiti will continue to afford it timely, complete and effective cooperation;
- 4. <u>Commends</u> the Haitian authorities on the progress accomplished in the advance of democracy, respect for human rights and the reconstruction of Haiti;
- 5. <u>Pays tribute</u> to the Haitian people in their ongoing quest for strong and lasting democracy, justice and economic prosperity;
- 6. <u>Expresses its appreciation</u> to those States participating in the United Nations Mission in Haiti and those that have accompanied the Haitian people in their efforts to return to constitutional order and democracy;
- 7. Expresses its confidence that the forthcoming presidential elections will further strengthen democracy in Haiti;

- 8. Reaffirms once again the commitment of the international community to continue its technical, economic and financial cooperation with Haiti in support of its economic and social development efforts and in order to strengthen Haitian institutions responsible for dispensing justice and guaranteeing democracy, respect for human rights, political stability and economic development;
- 9. <u>Commends</u> the cooperation between the Secretary-General of the United Nations and the Secretary-General of the Organization of American States in their efforts to promote respect for the rights of all Haitians and to contribute to the strengthening of democratic institutions, including through election monitoring;
- 10. <u>Requests</u> the Secretary-General to support the Government of Haiti as it works towards the national reconstruction and development of Haiti, in order to consolidate a climate propitious to the establishment of a lasting democracy and full respect for human rights;
- 11. <u>Also requests</u> the Secretary-General to continue to coordinate the efforts of the United Nations system to help provide humanitarian aid and meet the development requirements of Haiti;
- 12. <u>Further requests</u> the Secretary-General to submit to the General Assembly regular reports on the work of the International Civilian Mission to Haiti;
- 13.  $\underline{\text{Decides}}$  to keep the item entitled "The situation of democracy and human rights in Haiti" under review at its fiftieth session.
