The report summarizes the findings and conclusions reached, and outlines an approach to risk management and reserve funding that is more closely correlated to its circumstances and risk-exposure profile. The report and its recommendations have been reviewed and endorsed by the Management Coordination Committee.

The Programme of Action of the International Conference on Fopulation and Development (ICPD), held in Cairo, Egypt, in 1994, specified the financial resources (both domestic and donor funds) needed to implement the population and health package that was agreed upon at the conference.
