## INFORMATION CIRCULAR\*

Subject: 1998 NATIONAL COMPETITIVE RECRUITMENT EXAMINATIONS

1. The purpose of the present information circular is to invite applications from staff members in the General Service and related categories of the Secretariat who wish to take the national competitive recruitment examinations at the P-2 and P-3 levels in 1998, in accordance with the provisions of administrative instruction ST/AI/1997/1.

2. The 1998 National Competitive Recruitment Examinations will be held from 9 to 13 February 1998 in the following occupational groups in accordance with the needs of the Organization: administration (P-2/3), demography (P-3), economics (P-2/3), electronic data processing (P-2/3), finance (P-2/3), legal affairs (P-2/3), public information (P-2/3), social affairs (P-2) and statistics (P-2/3).

3. A list of the participating Member States and the occupational groups assigned to each participating Member State is contained in the annex to the present circular.

4. Staff members who meet the conditions set out in administrative instruction ST/AI/1997/1 may apply by completing the attached application form and forwarding it to: 1998 National Competitive Recruitment Examinations (Staff Members), Examinations and Tests Section, room S-2590A, Specialist Services Division/Office of Human Resources Management, by 30 September 1997. The most recent performance appraisal form and copies of all university degrees obtained must be attached to the application.
