SUMMARY STATEMENT BY THE SECRETARY-GENERAL ON MATTERS OF  
WHICH THE SECURITY COUNCIL IS SEIZED AND ON THE STAGE  
REACHED IN THEIR CONSIDERATION

Addendum

Pursuant to rule 11 of the provisional rules of procedure of the Security Council, the Secretary-General is submitting the following summary statement.

The complete list of items of which the Security Council is seized is contained in document S/11593 of 7 January 1975 and the pertinent addenda. During the week ending 1 June 1975, the Security Council took action on the following items:

The Security Council resumed its consideration of the question at its 1799th meeting, held on 23 October 1974, and included in its agenda the report of the Secretary-General on the United Nations Disengagement Observer Force (S/11694).

The President announced that the Security Council had received a draft resolution, circulated in document S/11700, which had been elaborated in the course of intensive consultations among all the members of the Council. The draft resolution was then put to the vote. The Security Council adopted the draft resolution (S/11700) as resolution 369 (1975) by 13 votes to none, with no abstentions. China and Iraq did not participate in the vote. In its operative paragraph, resolution 369 (1975) reads as follows:

Decides:

- (a) To call upon the parties concerned to implement immediately Security Council resolution 338 (1973);
- (b) To renew the mandate of the United Nations Disengagement Observer Force for another period of six months;
- (c) To request the Secretary-General to submit at the end of this period a report on the developments in the situation and the measures taken to implement Security Council resolution 338 (1973).

Pursuant to paragraph 6 of resolution 366 (1974), the Security Council resumed its consideration of the item at its 1823rd meeting, held on 30 May 1975. The President, with the consent of the Council, invited the representatives of Burundi, Ghana, India, Liberia, Nigeria, Senegal, Somalia and Zambia, at their request, to participate in the discussion without the right to vote.

As requested in a letter dated 29 May 1975 from the President of the United Nations Council for Namibia, and in accordance with past practice, the President, with the consent of the Council, extended an invitation, under rule 39 of the provisional rules of procedure, to a delegation of the United Nations Council for Namibia. The Council further decided, pursuant to the request contained in a letter dated 30 May 1975 (S/11705), from the representatives of Mauritania, the United Republic of Cameroon and the United Republic of Tanzania, to extend an invitation, under rule 39 of the Council's provisional rules of procedure, to Mr. Sam Nujoma and his delegation.
