### <u>Annotations</u>

1. Adoption of agenda and organization of work

Pursuant to a decision taken at its thirty-seventh session on 3 July 1997,<sup>1</sup> the Committee for Programme and Coordination held a resumed organizational

session on 5 September 1997 at United Nations Headquarters in order to decide on its further consideration of the sections of the proposed programme budget that will be affected by reform measures after publication of the revised budget proposals.

At that meeting, the Committee decided to resume its thirty-seventh session at United Nations Headquarters for up to five days beginning 13 October 1997, so as to consider the revised budget proposals for those sections of the proposed programme budget affected by reform measures, as well as the two outstanding sections of the budget, namely sections 27C (Office of Human Resources Management) and 27E (Conference services) that the Committee was unable to consider during its thirty-seventh session.

#### 2. <u>Programme questions</u>

- (a) <u>Proposed programme budget for the biennium 1998-1999</u>
- (b) <u>United Nations reform: measures and proposals</u>

Pursuant to its terms of reference (annex to Economic and Social Council resolution 2008 (LX) of 14 May 1976), and in accordance with regulations 4.7 and 4.8 of the Regulations and Rules Governing Programme Planning, the Programme Aspects of the Budget, the Monitoring of Implementation and the Methods of Evaluation, the Committee will resume its consideration of the relevant sections of the proposed programme budget for the biennium 1998-1999, as described below.

It should be recalled that at its thirty-seventh session, the Committee considered the various sections of the proposed programme budget for the biennium 1998-1999 and presented its recommendations on some of the programme narratives to the General Assembly for its consideration at its fifty-second session.<sup>2</sup> The Committee, in paragraph 56 of its report, had expressed regret that the Secretariat was not in a position to provide it with budget sections 27C, Office of Human Resources Management, and 27E, Conference services, for its consideration. The Committee will therefore consider those two subsections of the proposed programme budget for the biennium 1998-1999 during the resumed thirty-seventh session.

Also, at its resumed organizational session, the Committee was informed that the following sections of the proposed programme budget for the biennium 1998-1999, which are affected by the reform measures, may be subject to further consideration by the Committee for Programme and Coordination at its resumed thirty-seventh session:
