MEASURES TO ELIMINATE INTERNATIONAL TERRORISM

Draft report of the Working Group (Part I)

Chairman: Mr. Philippe KIRSCH (Canada)

I. INTRODUCTION

- 1. The General Assembly, by its resolution 51/210 of 17 December 1997, decided to establish an Ad Hoc Committee, open to all States Members of the United Nations or members of specialized agencies or of the International Atomic Energy Agency, to elaborate, <u>inter alia</u>, an international convention for the suppression of terrorist bombings. The Assembly recommended that the work of the Ad Hoc Committee, which held its first session from 27 February to 3 March 1997, continue during the fifty-second session of the Assembly from 22 September to 3 October 1997 in the framework of a working group of the Sixth Committee.
- 2. In accordance with that recommendation, the Sixth Committee, at its 2nd meeting, on 22 September 1997, established such a Working Group and elected Mr. Philippe Kirsch (Canada) as its Chairman.
- 3. Pursuant to the decision taken by the Sixth Committee at its 2nd meeting, the Working Group was open to all States Members of the United Nations or members of specialized agencies or of the International Atomic Energy Agency.
- 4. The Working Group held 17 meetings, from 22 September to 3 October 1997.
- 5. The Working Group had before it the report of the Ad Hoc Committee on the work of its first session, 1 which included revised texts of articles 1 to 12 <u>ter</u> of the draft convention proposed by the Bureau on the basis of the discussions in the informal consultations within the Ad Hoc Committee. Those texts were reproduced together with the preamble and articles 13 to 17 of the original

draft convention contained in the preliminary working document submitted by France on behalf of the group of seven major industrialized countries and the Russian Federation. 2

6. The Working Group also had before it the following proposals submitted during its work:
