I. ORGANIZATION OF THE SESSION

1. Pursuant to the decision taken at its resumed organizational session, on 5 September 1997 (29th meeting), the Committee for Programme and Coordination held its resumed thirty-seventh session at United Nations Headquarters from 13 to 17 October 1997. It held six meetings (30th to 35th meetings) and _____ informal consultations.

A. Agenda
