> COMPREHENSIVE REVIEW OF THE WHOLE QUESTION OF PEACEKEEPING OPERATIONS IN ALL THEIR ASPECTS

Argentina, Canada, Egypt, Japan, Nigeria and Poland: revised draft resolution

The General Assembly,

<u>Recalling</u> its resolution 2006 (XIX) of 18 February 1965 and all other relevant resolutions,

Recalling in particular its resolution 51/136 of 13 December 1996,

<u>Taking note</u> of the report of the Secretary-General on the work of the Organization, 1

<u>Affirming</u> that the efforts of the United Nations in the peaceful settlement of disputes, including through its peacekeeping operations, are indispensable,

<u>Welcoming</u> the expansion of the membership of the Special Committee on Peacekeeping Operations,

<u>Convinced</u> of the need for the United Nations to continue to improve its capabilities in the field of peacekeeping and to enhance the effective and efficient deployment of its peacekeeping operations,

<u>Considering</u> the contribution that all States Members of the Organization make to peacekeeping,

<u>Taking note</u> of the widespread interest in contributing to the work of the Special Committee expressed by many Member States, in particular troopcontributing countries,

<u>Bearing in mind</u> the continuous necessity of preserving the efficiency and strengthening the effectiveness of the work of the Special Committee,

1. Welcomes the report of the Special Committee on Peacekeeping Operations; $^{\rm 2}$

2. <u>Endorses</u> the proposals, recommendations and conclusions of the Special Committee contained in paragraphs 34 to 91 of its report;

3. <u>Urges</u> Member States, the Secretariat and relevant organs of the United Nations to take all necessary steps to implement the proposals, recommendations and conclusions of the Special Committee;

4. <u>Reiterates</u> that those Member States that become personnel contributors to United Nations peacekeeping operations in years to come or participate in the future in the Special Committee for three consecutive years as observers shall, upon request in writing to the Chairman of the Committee, become members at the following session of the Committee;

5. <u>Decides</u> that the Special Committee, in accordance with its mandate, shall continue its efforts for a comprehensive review of the whole question of peacekeeping operations in all their aspects and shall review the implementation of its previous proposals and consider any new proposals so as to enhance the capacity of the United Nations to fulfil its responsibilities in this field;

6. <u>Requests</u> the Special Committee to submit a report on its work to the General Assembly at its fifty-third session;

7. <u>Decides</u> to include in the provisional agenda of its fifty-third session the item entitled "Comprehensive review of the whole question of peacekeeping operations in all their aspects".
