REVIEW OF THE IMPLEMENTATION OF THE DECLARATION ON THE STRENGTHENING OF INTERNATIONAL SECURITY

Report of the First Committee

Rapporteur: Mr. Miloš KOTEREC (Slovakia)

I. INTRODUCTION

- 1. The item entitled "Review of the Implementation of the Declaration on the Strengthening of International Security" was included in the provisional agenda of the fifty-second session of the General Assembly in accordance with Assembly decision 51/415 of 10 December 1996.
- 2. At its 4th plenary meeting, on 19 September 1997, the General Assembly, on the recommendation of the General Committee, decided to include the item in its agenda and to allocate it to the First Committee.
- 3. At its 2nd meeting, on 9 October 1997, the First Committee decided to hold a general debate on all disarmament and international security items allocated to it, namely, items 62 to 82, which was held at the 3rd to 12th meetings, from 13 to 17 and from 20 to 24 October (see A/C.1/52/PV.3-12). Structured discussions of specific subjects on the adopted thematic approach were held at six informal meetings from 27 to 31 October 1997. Draft resolutions on the items were considered at the 15th to 17th meetings, from 5 to 7 November (see A/C.1/52/PV.15-17); action was taken on them at the 18th to 24th meetings, from 10 to 14 and on 17 November (see A/C.1/52/PV.18-24).

II. CONSIDERATION OF DRAFT DECISION A/C.1/52/L.13

- 5. At the 16th meeting, on 6 November, the representative of Indonesia, on behalf of the States Members of the United Nations that are members of the Movement of Non-Aligned Countries, introduced a draft decision, entitled "Review of the implementation of the Declaration on the Strengthening of International Security" (A/C.1/52/L.13), which was later also sponsored by Costa Rica.
- 6. At its 21st meeting, on 12 November, the First Committee adopted draft decision A/C.1/52/L.13 by a recorded vote of 96 to 0, with 48 abstentions (see para. 7). The voting was as follows: 1
