Addendum

1. Draft resolution A/52/L.19/Rev.1 differs from draft resolution A/52/L.19 in respect of operative paragraphs 6 and 7: the mandate period of the Mission would be shortened by moving ahead the previously indicated termination date from 31 December 1999 to 31 December 1998, with a report requested from the Secretary-General on the Mission after that date. Specifically, under operative paragraphs 6 and 7 of draft resolution A/52/L.19/Rev.1, the General Assembly would:

(a) Decide to authorize the renewal of the mandate of the Mission from 1 April to 31 December 1998;

(b) Request the Secretary-General to submit an updated report to the General Assembly at its fifty-third session, with his recommendations on the structure and staffing for the Mission after 31 December 1998.

2. The existing statement of the programme budget implications of draft resolution A/52/L.19 remains valid in all respects, subject only to an amendment in the related cost requirements (see A/C.5/52/21, para. 24), which would be

\$28,200,000 (\$29,962,800 gross) as opposed to \$61,815,100 (\$66,654,800 gross), reflecting provision for 9 months (1 April-31 December 1998) as opposed to the 21 months (1 April 1998-31 December 1999) previously foreseen.

3. Should the General Assembly decide to adopt draft resolution A/52/L.19/Rev.1, an additional appropriation of \$28,200,000 would be required under section 3 of the proposed programme budget for the biennium 1998-1999. An additional appropriation of \$1,752,800 would also be required under section 32, Staff assessment, to be offset by a corresponding amount under section 1, Income from staff assessment.
