SUMMARY STATEMENT BY THE SECRETARY-GENERAL ON MATTERS OF
WHICH THE SECURITY COUNCIL IS SEIZED AND ON THE STAGE
REACHED IN THEIR CONSIDERATION

Addendum

Pursuant to rule 11 of the provisional rules of procedure of the Security Council, the Secretary-General is submitting the following summary statement.

The list of items of which the Security Council is seized is contained in documents S/1997/40 of 10 January 1997, S/1997/40/Add.10 of 21 March 1997, S/1997/40/Add.20 of 30 May 1997, S/1997/40/Add.21 of 6 June 1997, S/1997/40/Add.28 of 25 July 1997, S/1997/40/Add.29 of 1 August 1997, S/1997/40/Add.31 of 15 August 1997, S/1997/40/Add.32 of 22 August 1997, S/1997/40/Add.38 of 3 October 1997 and S/1997/50/Add.41 of 24 October 1997.

During the week ending 15 November 1997, the Security Council took action on the following items:

The situation between Iraq and Kuwait (see S/21100/Add.30-33, 36-38, 42, 43 and 47; S/22110/Add.6-9, 13, 14, 17, 20, 24, 25, 32, 37 and 40; S/23370/Add.8, 11, 28, 34 and 39; S/25070/Add.1, 2, 5, 21, 24 and Corr.1, 26 and 47; S/1994/20/Add.8, 39-41 and 45; S/1995/40/Add.14; S/1996/15/Add.11, 12, 23 and 33; and S/1997/40/Add.15, 22-24, 36, 42 and 43; see also S/23370/Add.10, 32, 35 and 47)

The Security Council resumed its consideration of the item at its 3831st meeting, held on 12 November 1997 in accordance with the understanding reached in its prior consultations.

The President drew attention to the text of a draft resolution (S/1997/872), that had been submitted by the United Kingdom of Great Britain and Northern Ireland and the United States of America. Subsequently, Chile, Costa Rica, Japan, Poland, Portugal, the Republic of Korea and Sweden joined in sponsoring the draft resolution contained in document S/1997/872.

The Security Council proceeded to vote on draft resolution S/1997/872, and adopted it unanimously as resolution 1137 (1997) (for the text, see

S/RES/1137 (1997); to be issued in Official Records of the Security Council, Fifty-second Year, Resolutions and Decisions of the Security Council, 1997).

The Security Council resumed its consideration of the item at its 3832nd meeting, held on 13 November 1997 in accordance with the understanding reached in its prior consultations.

The President stated that, following consultations of the Council, he had been authorized to make a statement on behalf of the Council and read out the text of that statement (for the text, see S/PRST/1997/51; to be issued in Official Records of the Security Council, Fifty-second Year, Resolutions and Decisions of the Security Council, 1997).

The situation in Tajikistan and along the Tajik-Afghan border (see S/25070/Add.34; S/1994/20/Add.37, 44 and 49; S/1995/40/Add.14, 19, 23, 33, 44 and 49; S/1996/15/Add.20, 23, 37 and 49; and S/1997/40/Add.5, 10, 23 and 36; see also S/23370/Add.43)

The Security Council resumed its consideration of the item at its 3833rd meeting, held on 14 November 1997 in accordance with the understanding reached in its prior consultations, having before it the report of the Secretary-General on the situation in Tajikistan (S/1997/859).

The President, with the consent of the Council, invited the representative of Tajikistan, at his request, to participate in the discussion without the right to vote.

The President drew attention to the text of a draft resolution (S/1997/887), that had been prepared in the course of the Council's prior consultations.

The Security Council proceeded to vote on draft resolution S/1997/887, and adopted it unanimously as resolution 1138 (1997) (for the text, see S/RES/1138 (1997); to be issued in Official Records of the Security Council, Fifty-second Year, Resolutions and Decisions of the Security Council, 1997).

The situation in Sierra Leone (see S/1995/40/Add.47; S/1996/15/Add.6, 11 and 48; and S/1997/40/Add.21, 27, 31 and 40)

The Security Council resumed its consideration of the item at its 3834th meeting, held on 14 November 1997 in accordance with the understanding reached in its prior consultations.

The President, with the consent of the Council, invited the representative of Sierra Leone, at his request, to participate in the discussion without the right to vote.

The President stated that, following consultations of the Council, he had been authorized to make a statement on behalf of the Council and read out the text of that statement (for the text, see S/PRST/1997/52; to be issued in Official Records of the Security Council, Fifty-second Year, Resolutions and Decisions of the Security Council, 1997).
