Annex. Report of the Fourth Meeting of the Expert Group on International Economic and Social Classifications

Section I will review the actions taken by the Statistical Commission and activities carried out in response to requests of the Commission. It will cover actions taken by the United Nations Statistics Division to coordinate economic and social classifications, paying particular attention to a strategic plan of action for future classifications work; international agreement on basic principles for the development and use of international classifications; publishing and dissemination of the Central Product Classification, Version 1.0; revision of classifications of expenditure according to purpose; development of trade-in service classifications; strategies for bridging differences between commodity nomenclatures; increased development and use of classifications database management techniques; and central registration of problems regarding consistency of concepts and measurement of the newly prepared Central Product Classification, Version 1.0.

Section II will cover additional work, including the conducting of international training workshops; extension of the Classifications Hotline to provision of classifications services using the World Wide Web; and identifying the custodians or official points of contact of the family of international economic and social classifications, and increasing collaboration among them.

Report of the Inter-Agency Task Force on Service Statistics

Proposed outline

The report will provide an overview of activities completed by the Task Force to address the recommendation of the Statistical Commission to ensure consistency between the fifth edition of the Balance of Payments Manual, the Central Product Classification (CPC), Version 1.0, the System of National Accounts 1993, and the manual on trade in services statistics proposed by the Task Force. The Commission also recommended that the contents of the proposed manual be consistent with the findings of Working Party No. 9 of the Industry Committee on Industrial Statistical Globalization of the Organization for Economic

Cooperation and Development. The Statistical Commission will be informed that the Task Force has requested that its name be changed to "Task Force on Statistics of International Trade in Services" in order to more accurately reflect its current mandate, which focuses on problems related to the collection of data on trade in services.
