Note by the Secretariat

1. The draft organization of work of the Commission for Social Development at its thirty-sixth session, which is contained in the annex, has been prepared pursuant to relevant decisions of the General Assembly and the Economic and Social Council in order to facilitate the consideration of agenda items within the time-frame available and in accordance with the conference services allocated to the Commission.
2. The draft is based on the provisional agenda adopted at the thirty-fifth session and approved by the Council in its decision 1997/230.
3. Within the eight working days allotted to the thirty-sixth session, time is reserved for: a special presentation on the follow-up to the World Summit for Social Development; two panel discussions on the priority theme for the session: "Promoting social integration of all people, including disadvantaged and vulnerable groups and persons"; a presentation on the social dimensions of drug abuse; and two non-governmental organizations segments.
4. The timetable contained in the annex should be considered tentative and indicative; if the Commission completes its consideration on an item ahead of schedule, it may wish to proceed immediately to the next item.
5. The Commission is scheduled to meet from Tuesday, 10 February to Friday, 20 February 1998, Monday, 16 February being an official holiday. Arrangements have been made to hold morning and afternoon meetings during the session; morning meetings will be held from 10 a.m. to 1 p.m., and afternoon meetings from 3 p.m. to 6 p.m.
