Adoption of concluding observations

- 1. <u>The CHAIRPERSON</u> invited the Committee to adopt its concluding observations concerning the initial reports of States parties considered at its seventeenth session.
- 2. Mrs. MBOI (Rapporteur) said that action to implement the Convention was uneven almost everywhere, partly because the full scope of children's rights was only gradually becoming clear and partly because of varying national priorities, resource limitations and, in some cases, conflicts between traditional values and the global consensus on children's rights. The Committee hoped through its suggestions and recommendations to facilitate the ongoing process of national and international reflection and action aimed at the universal enforcement of children's rights.

Initial report of the Libyan Arab Jamahiriya (CRC/C/28/Add.6)
