انتخاب أعضاء اللجنة الفرعية لمنع التمييز وحماية الأقليات

مذكرة من الأمين العام*

١- طبقاً لقراري المجلس الاقتصادي والاجتماعي ١٢٣٤ (د - ٤٤) المؤرخ في ٣١ أيار/مايو ١٩٦٨ و٣٥/١٩٨٦ المؤرخ في ٢٣ أيار/مايو ١٩٨٦، ومقرريه ٢١/١٩٧٨ المؤرخ في ٥ أيار/مايو ١٩٧٨ و١٠٢/١٩٨٧ المؤرخ في ٦ شباط/فبراير ١٩٨٧، قامت لجنة حقوق الإنسان في دورتها الرابعة والأربعين (الجلسة ٢٩، ٢٩ شباط/فبراير ١٩٨٨) بانتخاب ٢٦ عضواً في اللجنة الفرعية لمنع التمييز وحماية الأقليات بالاقتراع السري من بين الخبراء الذين رشحتهم الدول الأعضاء في الأمم المتحدة على النحو التالي: (أ) سبعة أعضاء من الدول الأفريقية؛ (ب) خمسة أعضاء من الدول الآسيوية؛ (ج) ثلاثة أعضاء من دول أوروبا الشرقية؛ (د) خمسة أعضاء من دول أمريكا اللاتينية؛ (هـ) ستة أعضاء من دول أوروبا الغربية ودول أخرى.

٢- ووفقاً لقرار المجلس ٣٥/١٩٨٦، ينتخب أعضاء اللجنة الفرعية لفترة أربع سنوات، وينتخب نصف أعضاء اللجنة الفرعية والعدد المقابل من المناوبين، إن وجد، مرة كل عامين. وقام رئيس الدورة الرابعة والأربعين للجنة حقوق الإنسان بإجراء القرعة لانتخاب الأعضاء، وعند الاقتضاء، العدد المناظر من المناوبين الذين ستنتهي فترة ولايتهم بعد عامين وفقاً للنمط التالي: ثلاثة أعضاء من الدول الأفريقية؛ وثلاثة أعضاء من الدول الآسيوية؛ وعضو واحد من دول أوروبا الشرقية؛ وثلاثة أعضاء من دول أمريكا اللاتينية؛ وثلاثة أعضاء من دول أوروبا الغربية ودول أخرى.

* نظراً لطول المذكرة، يصدر المرفق الأول بهذه الوثيقة، باللغات الأصلية فقط، إذ لا تتوفر لشعبة شؤون المؤتمرات التابعة لمكتب الأمم المتحدة في جنيف القدرة الكافية على ترجمة الوثائق التي تتجاوز، إلى حد كبير، حد الـ ٣٢ صفحة الذي أوصت به الجمعية العامة (انظر قرار اللجنة ٩٤/١٩٩٢، الفقرة ١).

٣- وفي الأعوام ١٩٩٠ و ١٩٩٢ و ١٩٩٤ و ١٩٩٦ عندما انتهت فترة ولاية نصف أعضاء اللجنة الفرعية، أجرت لجنة حقوق الإنسان في دوراتها السادسة والأربعين والثامنة والأربعين والخمسين والثانية والخمسين انتخابات جديدة لأعضاء اللجنة الفرعية ومناوبيهم^(١).

٤- ويحتوي المرفق الثاني على قائمة بأسماء الأعضاء الحاليين في اللجنة الفرعية.

٥- ولما كانت مدة ولاية نصف أعضاء اللجنة الفرعية قد انقضت مرة أخرى، فإن لجنة حقوق الإنسان مدعوة في دورتها الرابعة والخمسين لإجراء انتخاب جديد لأعضاء اللجنة الفرعية والمناوبين وفقاً للنمط التالي: ثلاثة أعضاء من الدول الأفريقية؛ وثلاثة أعضاء من الدول الآسيوية؛ وعضو من دول أوروبا الشرقية؛ وثلاثة أعضاء من دول أمريكا اللاتينية؛ وثلاثة أعضاء من دول أوروبا الغربية ودول أخرى.

٦- وأكدت لجنة حقوق الإنسان من جديد، في قرارها ٢٢/١٩٩٧ المؤرخ في ١١ نيسان/أبريل ١٩٩٧، أنه ينبغي أن يؤدي أعضاء اللجنة الفرعية مهامهم بصفتهم الشخصية، ودعت الدول إلى أن ترشح للعمل كأعضاء ومناوبين خبراء مستقلين ممن يشهد لهم بالكفاءة في ميدان حقوق الإنسان. وإلى أن تحترم بالكامل استقلال الأعضاء والمناوبين المنتخبين. وطلبت اللجنة أيضاً إلى الدول التي تسمي مرشحين للجنة الفرعية تقديم ترشيحات في وقت مبكر بقدر كاف لتمكين أعضاء لجنة حقوق الإنسان من أن يقيّموا مؤهلات المرشحين بدقة. وتجدر الإشارة إلى أن اللجنة الفرعية كانت قد استرعت انتباه لجنة حقوق الإنسان بوجه خاص، في قرارها ٣٢/١٩٨٧، إلى توصية الفريق العامل المعني بأشكال الرق المعاصرة للجنة حقوق الإنسان بأن تحاول هذه الأخيرة إقناع جميع الحكومات بترشيح مزيد من النساء لانتخابهن في اللجنة الفرعية.

٧- وفيما يتعلق بتسمية المناوبين، اعتمد المجلس الاقتصادي والاجتماعي القرار ٣٢/١٩٨٣ الذي قرر فيه أنه:

"... بصرف النظر عن الفقرة ٢ من المادة ١٣ من النظام الداخلي للجان الفنية للمجلس الاقتصادي والاجتماعي، تسري القواعد التالية من الآن فصاعداً على اللجنة الفرعية لمنع التمييز وحماية الأقليات:

(أ) يجوز أن تصحب تسمية المرشح لعضوية اللجنة الفرعية تسمية خبير من نفس الجنسية ينتخب في آن واحد مع المرشح للعضوية ويمكن أن يعمل مؤقتاً بصفة مناوب له في حالة عدم استطاعة العضو الحضور؛

(ب) تكون المؤهلات المطلوب توفرها في الأعضاء المناوبين هي نفسها المطلوب أن تتوفر في الأعضاء:

(ج) لا يجوز لأي شخص غير الخبير المنتخب كعضو مناوب أن يعمل كعضو مناوب لأحد الأعضاء، عملاً بالفقرة الفرعية (أ) أعلاه.

٨- وحتى ١٥ كانون الثاني/يناير ١٩٩٨ تلقى الأمين العام ترشيحات لانتخاب أعضاء اللجنة الفرعية من حكومات الاتحاد الروسي وأذربيجان وأرجنتين وأوغندا والبرازيل وسري لانكا والسنغال وشيلي والصين وغامبيا وفرنسا والفلبين والكاميرون ولبنان والمكسيك والمملكة المتحدة لبريطانيا العظمى وأيرلندا الشمالية وموريشيوس ونيجيريا والهند واليونان.

٩- وستعمم الرسائل والترشيحات الأخرى التي ترد من الحكومات كإضافات إلى هذه الوثيقة.

١٠- وترد أدناه قائمة بالترشيحات التي وردت من الحكومات حتى الآن، ويتضمن المرفق الأول بيانات السير الذاتية للمرشحين.

DETAILS OF EXPERIENCE:

1. Attorney-General's Office

I practised at the local bar for a few months before joining the Attorney-General's Office as Temporary Crown Counsel on 1 December 1972. I worked there until August 1976.

During the four years I was posted at the Attorney-General's Office, I had the following schedule of duties:

- (i) advising ministries;
- (ii) appearing for Government in civil litigation;
- (iii) representing the public minister whenever necessary;
- (iv) prosecuting criminal cases at the district and intermediate courts and at the assizes;
- (v) officer-in-charge of the Districts of Moka/Flacq for all criminal matters;
- (vi) actively involved with the Law Revision Unit under Professor Angelo.

2. District/Senior District Magistrate

I served as Magistrate from 1 September 1976, and was promoted senior District Magistrate on 22 May 1978.

As Magistrate/Senior District Magistrate, I have sat in practically all the district courts including Rodriguez and Agalega. The District Magistrate presides over his court and hears both civil and criminal cases. He also hears chambers cases in his capacity as "Judge de paix". He works with a staff comprising a district clerk, an assistant district clerk, recorders, ushers, court cashier, messengers, court orderlies, police prosecutor and probation officers. He is the person who has overall responsibility for the smooth despatch of court business and is therefore a person who must have a sense of leadership.

In my capacity as Magistrate I have also been called upon to chair committees of inquiry relating to disciplinary proceedings instituted against public officers and boards of assessment relating to the compulsory acquisition of land by Government. I have also chaired the Prisons Board, a work undertaken "de bono" on Saturdays. Offences against prison discipline by detainees are tried and the board ascertains that conditions of detention are not oppressive and inhuman.

3. Magistrate Intermediate/Industrial Court

From February 1980 to June 1981, I have served as Magistrate Intermediate Court/Magistrate Industrial Court in an acting capacity on three occasions. I was appointed Magistrate Industrial Court on 1 July 1981. The Intermediate Court deals with the more serious criminal cases which are

referred by the Director of Public Prosecutions. Civil claims are also heard. The Industrial Court moreover, deals with labour disputes during which conciliation is frequently resorted to.

4. Presiding Magistrate Industrial/Intermediate Court

I have served as Presiding Magistrate Industrial Court in an acting capacity on four occasions, between 2 November 1982 and November 1983. I was appointed Presiding Magistrate Intermediate Court on 1 December 1983.

5. Judge in Bankruptcy and Master and Registrar

I served as Judge in Bankruptcy and Master and Registrar in an acting capacity with effect from 1 September 1984 and appointed to that post in a substantive capacity on 18 August 1986. The Master and Registrar is in fact the "Permanent Secretary" of the Judicial Department. He is the liaison officer between the department and other ministries, between the Chief Justice and the entire staff including the magistrates. He ascertains that all the courts are adequately staffed, that there is no backlog in any specific court by close monitoring through monthly returns. He also keeps the Rolls of Law Practitioners, compiles the jury list. Quite apart from administrative responsibilities, the Master has a sizeable amount of judicial work as well viz. he conducts judicial sales before the Master's Bar, is in charge of divisions in kind, sits at the bankruptcy court with the title of "Judge of the Bankruptcy Court". The Master and Registrar is now helped by a Deputy Master and Registrar, a post which has recently been created. In my capacity as Master and Registrar, I was also the Chairman of the Central Probation Committee.

During my term of office as Master and Registrar I was involved with two notable happenings, viz. (i) the laying of the foundation stone for the New Court House which is now nearing completion, and; (ii) the preparations marking the celebration of the bicentenary of the Mauritian Bar in May 1987.

6. Puisne Judge

I was appointed Judge on 23 January 1989.

7. Senior Puisne Judge

I was appointed Senior Puisne Judge on 10 August 1995.

The Senior Puisne Judge is a de facto member of the Judicial and Legal Service Commission. Over and above his duties as Puisne Judge, he is in charge of matrimonial matters and Chambers matters. He accordingly deals every week with all the formal matters in matrimonial cases and distributes the case load of cases which are in shape. He also ascertains that a proper roster is maintained to ensure the availability of judges for urgent matters especially during court vacation.

8. Parajudicial functions

- (i) In 1982-1983, I have lectured in French Civil Law at the University of Mauritius for the Diploma in Civil Law Course.
- (ii) In 1983-1984 I was elected and served as President of the Magistrates' Association of Mauritius, an association affiliated to the Commonwealth Magistrates' and Judges' Association which is based in London.
- (iii) From 1984 to 1986, I have sat on the Board of the Council of Legal Education.

- (iv) I have also on numerous occasions served as Examiner/Chairman of Board of Examiners at the examinations held for the three branches of the legal profession, viz. notary, attorney and barrister.
- (v) In 1988, I was chosen by Sir Cassarn Moolan, then Chief Justice, to represent the Judiciary of Mauritius at the Commonwealth Magistrates and Judges Conference in Halifax, Canada.
- (vi) In 1989-1990, I have lectured at the Council of Legal Education in Commercial Law.
- (vii) In September 1990, I was chosen by Sir Victor Glover, then Chief Justice, to represent the Mauritius Judiciary at a conference held in Beijing by the World Jurists Association and sat as a panellist on the "Judiciary Panel".
- (viii) In 1990-1991, I presided over the Commission of Inquiry on the National Handicraft Centre.

9. I.T. development

In November 1989, I was requested by Sir Victor Glover, to study and appraise the advisability of introducing computers within the court environment and to be in charge of the I.T. development programme at the Supreme Court. I am still in charge of that project which has gone a long way towards intensive implementation.

The main achievements so far are:

- (a) The staff of the Supreme Court is now computer literate to an appreciable degree and all the sections of the Supreme Court are now computerized;
- (b) There is a LAN (Local Area Network) which permits all judges to access from their individual chambers data (judgements of the Supreme Court) which are stored in a main server. Research is also possible through a programme which permits text retrieval;
- (c) We have recently received a Minitel at the Supreme Court giving us access to French legal database.

I have visited "technology courts" in Singapore, Hong Kong and Australia which use the computer as a major productivity tool. Very soon we are moving to the next stage of development which will permit Digital recording of court proceedings on a D.A.T. (Digital Audio Tape) and which will appreciably shorten hearing time at the Supreme Court.

I have also initiated a project to reprint the Mauritius reports which date back to 1861. This project has now reached the finalization stage. The data will be electronically stored and made available on CD-Rom as well.

10. Social activities

- (i) I am serving on the Board of Governors of St. Joseph's College and have been doing so for the past 5 years. The Board sets and streamlines policies. It also ascertains that there is no material want which would hamper the progress of the college;
- (ii) I have been a member of the Lions Club of Port Louis for over 10 years. I was President for the year 1988-1989 and have represented my club in Reunion and Madagascar. This year I was awarded the Melvin Jones Fellowship which is the highest award of the Lions Clubs International Association.
