### Introduction

1. The present addendum supplements and updates the information communicated at the fifty-second session of the Commission on Human Rights, which is contained in the annual report of the Secretary-General to the General Assembly (A/52/387) and in the annual report of the Secretary-General to the Commission on Human Rights (E/CN.4/1998/37).

# Payment of grants decided upon in 1997

2. A sum of \$160,000 decided on in 1997 under pending grants was paid to 15 projects for assistance to victims of torture for which additional information had been requested by the Board of Trustees and the secretariat.

The contribution of \$8,888 paid to the Fund by South Africa on 31 March 1996 through the UNDP office in Pretoria was actually received by the United Nations Cashier's Office on 31 May 1996.

# Cash requirements before May 1998

4. The contributions received since the last session of the Board of Trustees currently total \$2 million, while requests received for grants amount to around \$7 million, as in 1997. Hence the Fund is \$5 million short of the amount needed to meet all the requests. Pledges totalling \$2,974,952 have been made by the 15 States listed below. As requested by the Commission on Human Rights in its resolution 1997/38, the High Commissioner has reminded these Governments that their contributions should be paid before 11 May 1998, the date of the next meeting of the Board of Trustees. Contributions received after that date will be processed by the Board of Trustees only at its next session, in May 1999.

# Project funding cycle

- 5. Following the session of the Board, the recommendations concerning grants are approved by the High Commissioner for Human Rights, on behalf of the Secretary-General, in June. Payments to organizations are made in July following approval by the Budget Service. The organizations must then submit, before 31 December, a narrative report and a financial report on the use to which the grants have been put. They must transmit a new request for funding to the secretariat before that date if they wish to benefit from Fund support during the following year.
- 6. Many of the projects supported by the Fund also receive grants from the European Union. However, the EU has adopted new guidelines under which grants are paid only in December. This increases the organizations' dependence on the United Nations Fund in order to start up their projects during the year. Hence it is of prime importance that contributions to the Fund are paid each year before the session of the Board of Trustees so that the Fund is in a position to respond to growing demand for assistance, and so that there is no break in the programme of assistance to victims.
