LETTER DATED 6 APRIL 1998 FROM THE PERMANENT REPRESENTATIVE OF  
IRAQ TO THE UNITED NATIONS ADDRESSED TO THE PRESIDENT OF THE  
SECURITY COUNCIL

On instructions from my Government, I have the honour to transmit to you herewith a letter dated 5 April 1998 addressed to you by Mr. Mohammed Said Al-Sahaf, Minister for Foreign Affairs of the Republic of Iraq, concerning violations of Iraq's airspace by the United States U-2 spy aircraft on the pretext of carrying out an aerial survey for the Special Commission.

I should be grateful if you would have the present letter and its annex circulated as a document of the Security Council.

Letter dated 5 April 1998 from the Minister for Foreign Affairs  
of Iraq addressed to the President of the Security Council

We refer to our letter dated 28 January 1998 addressed to the President of the Security Council (S/1998/89, annex), concerning the violation of Iraq's airspace by the United States U-2 spy plane on the pretext of carrying out an aerial survey for the Special Commission.

We should like to inform you that this aircraft, which is based in Saudi Arabian territory, has continued its incursions into Iraq's airspace in violation of the country's sovereignty and security. As of the end of February 1998, this aircraft had carried out 399 overflights for a total flight time of 1,752 hours and 18 minutes since its first overflight in August 1991.

The facts that have come to light since this aircraft was first brought into use, which are set forth in our aforementioned letter, and the ill repute the aircraft has acquired from its past espionage activities in various parts of the world make it incumbent upon the United Nations to re-examine the question of continuing to use an aircraft that is being employed by the United States of America in a coercive manner to violate Iraq's airspace and to spy on Iraq for purposes other than those of the Special Commission. Such policies are totally incompatible with the purposes and principles of the Charter of the United Nations as they relate to respect for the sovereignty of all Member States and non-interference in their internal affairs.

In condemning and deprecating these unwarranted violations of our airspace, we take this opportunity to reaffirm the request that we have constantly reiterated in the 129 letters on this subject that we have thus far addressed to the Secretary-General of the United Nations, namely, that Iraqi aircraft should be used instead of foreign aircraft in the work of the Special Commission in order to exclude any possibility of such aircraft being used for purposes prejudicial to Iraq's sovereignty and security.

I should be grateful if you would have this letter circulated as a document of the Security Council.
